
This Certificate is valid w.e.f. 31/5/2012 upto 30/5/2013.

This Certificate is issued subject to the conditions stipulated here under:-

- (i) Tests, examinations and inspections shall be carried out under direct supervision of the Competent Person or by a person so authorized by the institution recognized to be Competent Person.
- (ii) Tests, examinations and inspections shall be carried out in accordance with the provisions of the Act and that of Rules made thereunder.
- (iii) The Certificate of Competency issued in favour of a person shall stand cancelled if the person leaves the Organization mentioned in his application.
- (iv) The institution recognized as a Competent Person shall keep the Chief Inspector of Factories informed of the names, designation and qualification of the persons authorized by it to carry out test, Examination and inspections.
- (v) The report of examination of the above said plants equipments will be prepared in accordance with the relevant provisions of the Factories Act, 1948 and Delhi Factories Rules, 1950 and will be signed by the person making the examination/testing and will also be countersigned by the Head of the Institution with rubber stamp affixed thereon, in case of inspection has been carried out by a person so authorized by the institution and recognized to be competent person.

(vi) A monthly return shall be submitted giving names of factories, list of plants/equipments tested, date of testing and number and date of certificate issued with special remarks if any. This return should be submitted either personally or delivered under registered/speed post to the office of Chief Inspector of Factories by 10th of every succeeding month without fail.


