The term globalization mainly refers to the inter-dependence of individual economies of the world through uninhibited trade and financial flows, as also through mutual exchange of technology and knowledge. Though, there may not be a precise definition of the term, in today's world, it is important that new trends in the work economy are understood along with Liberalization, Privatization and Globalization (commonly referred to as LPG), its impact on developing nations including India economy.

TARGET BENEFICIARIES OF THE COURSE:

The Course has been designed to benefit those who are working in the Government, its local/autonomous bodies, public sector undertakings. The Course would be useful to all lower/middle level functionaries associated with dealing Globalization, Liberalization and WTO. Training Module is enclosed.

1. Differentiate the concept of Globalization, Liberalization and Privatization.
