OFFICE MEMORANDUM

It has been noticed that several Departments are not processing in time the bills raised by private empanelled hospitals in respect of treatment provided to employees of GNCT of Delhi under Delhi Govt. Employees Health Scheme (DGEHS). Delay in processing of bills and late payments to the hospitals is adversely affecting the provision of credit / cashless treatment facility under the scheme in emergent conditions, and as a result, empanelled hospitals are reluctant to provide cashless / credit facility to DGEHS beneficiaries.

2. All HODs are advised, in the interest of all members of DGEHS, that they may ensure payments are made to empanelled hospitals maximum within 60 days, as per standing agreement, after receipt of completed bills.

3. This may kindly be accorded priority.
