CIRCULAR

The payment of honorarium is a taxable income which has been made during the current financial year 2012-13. Since the staff deputed in State Election Commission are drawing salary from their parent department and at the time of making the payment this office could not compute the tax on the honorarium due to non-availability of relevant information.

It is therefore, requested to kindly issue necessary instructions/directions to concerned DDOs under your jurisdiction that an undertaking may be obtained from the staff deputed for election duty, about the amount received as honorarium for the duty performed during Election and the same may also be taken into account for assessing the Income Tax during the financial year 2012-13.
