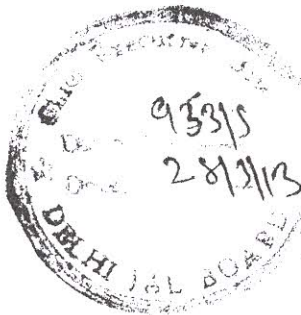
CIRCULAR

Sub:- Revision of wages in respect of part time workers.

In continuation of this office circular of even number dated 14.12.2006, I am hereby directed to intimate that the following revised rates of wages for part time workers have been fixed with effect from 01.10.2012

1. Rs.910/- per month for part-time workers employed for one hour per day;
2. Rs.1,820/- per month for part-time workers employed for two hour per day;
3. Rs.2,730/- per month for part-time workers employed for Three hour per day; and
4. Rs.3,640/- per month for part-time workers employed for four hour per day;
