The Haryana Electricity Regulatory Commission (HERC) was constituted in 1998 with a Chairman and two members under the Haryana Electricity Reforms Act, 1997 to regulate the Electricity Industry in the State. One post of Member would be vacant in HERC on 2.1.2014 due to the completion of the tenure of one of the present Member. A suitable person has to be selected for this post and a Selection Committee has been constituted for this purpose.

- 2. The qualifications for appointment of Member of State Commission and their term of office and conditions of service are provided in Section 84 and 89 of the Electricity Act, 2003, respectively. Pay and allowances of Chairperson and Members of the State Commission have been provided in Rule-3 of the Haryana Electricity Regulatory Commission (conditions of service of Chairman and Members) Rules, 1998 and amended vide notification dated 20.05.2009. An extract of Section 84, 89 of the Electricity Act, 2003 and Section-3 of the aforementioned rules is enclosed, for ready reference.
- 3. As per Section 84 of the Electricity Act 2003, the Chairperson and the Member of the State Commission shall be person of ability, integrity and standing who has adequate knowledge of and has shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. The chairperson and the Member of the State Commission shall not hold any other office as provided in sub-section (3) of Section 84 of the Electricity Act, 2003.
- 4. The Chairperson and the Member shall hold office for a term of five years from the date he enters upon his office provided that no member shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act.
- 5. As per Rule 3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules_1998 and amended vide notification dated 20.05.2009, pay of members shall be in the HAG plus scale of Rs. 75,500-80,900/- per month with grade pay nil and an annual increment at the rate of 3% subject to deduction of the gross amount of pension including any commuted portion thereof if already getting.
