#### CIRCULAR

Subject: - Admission Schedule for entry level classes (below six years of age) in recognized un-aided schools of Delhi for the session 2014-15:-

- In continuation of the Directorate of Education Order No: F.DE/ACT/2012/6022-35
  dated 13/12/2012 read with the orders/notifications detailed below, the following
  admission schedule and guidelines are issued for conducting admissions to entry
  level classes (below six years of age) for academic session 2014-15.
  - A. Order No: F.DE/15/1031/ACT/2013/12795-12809 dated 18.12.2013 regarding Amendment of 'Recognized Schools (Admission Procedure Pre-Primary Class) Order' No: F.DE/15/1031/ACT/2007/7002 dated 24/11/2007.
  - B. Notification No: F.15(172)/DE/Act/2010/4926-40 dated 17/10/2012 including 'Orphans' defined in the Juvenile Justice (Care & Protection of Children) Rules, 2007, within the meaning of Children belonging to Disadvantaged Group as defined in Section 2(d) of the RTE Act-2009. The Department of Women & Child Development, Govt of NCT of Delhi, vide order No: 61/495/Orphan/DD (CPU)/DWCD/2012-13/2682-842 dated 11/11/2012 has issued instructions regarding issuance of certificate declaring a child 'Orphan'. Copy of the same is enclosed as Annexure-I.
  - C. 'Neighbourhood Distance Criteria' devised by the Hon'ble Delhi High Court in their order dated 31/01/2012 regarding children belonging to <u>Economically</u> <u>Weaker Section & Disadvantaged Group</u> and subsequently circulated vide this Directorate's circular No: F.15(110)/DE/Act/2011/7563-74 dated 13/02/2012.
  - D. Order dated 24/05/2012 of the Hon'ble Delhi High Court in WPC No: 8434/2011 regarding granting 25% admission to children belonging to Economically Weaker Section & Disadvantaged Group at entry levels where <u>fresh admissions</u> are made in pre-school, pre-primary and Class-I and circulated vide this Directorate's circular No: 2393-2004 dated 04/06/2012.
  - E. Circular No. DE-15/Act-I/WPC No: 3168/13/2013/11734-11738 dated 14/11/2013 in the wake of Hon'ble High Court of Delhi Order dated 07/10/2013 in WPC No: 3168/13, waiving off the condition of minimum residency period of 03 years in Delhi for applying to admission under Economically Weaker Section & Disadvantaged Group Category.

- 3. The <u>date for displaying the list of selected children have been fixed</u> as above for strict compliance due to feedback / complaints received from the parents that problems were faced for refund of fee and other charges deposited with the schools on withdrawal of admission after securing admission in another school due to displaying of list of selected children on varying dates by the school.
- 4. No deviation from the above schedule shall be permitted. Each school shall display this admission schedule on its notice board and web site. Further each school shall ensure that admission applications are made available to all applicants till the last date of submission of admission applications i.e. 31/01/2014.
- 5. The Directorate of Education has devised a Common Registration Form for admission under EWS & Disadvantaged Category and the same is uploaded on the official website of Directorate of Education i.e. <a href="www.edudel.nic.in">www.edudel.nic.in</a> for the benefit of the schools as well as the applicants. Copy of the same is enclosed as Annexure-II. All the schools are directed to <a href="www.edudel.nic.in">use the said format only</a> by downloading the said form or using a printed version of the application form. Parents may get the Common Registration Form from the schools or may download the same from the above mentioned website. Every school shall ensure that the Registration forms in the prescribed Proforma are made available free of cost to all applicants under EWS & Disadvantaged Group Category without any barrier / hindrance.
- Further, all schools shall comply with the notification dated 28/02/2012 which directs that the number of seats at the entry level/s shall not be less than the highest number of seats in the entry class during the previous three academic years i.e. 2011-12, 2012-13 & 2013-14.
- 7. The minority schools, which have been allotted land by the Govt. Agencies shall admit the children belonging to EWS category to the extent of 20% at entry level and provide free-ship to them till the completion of their school education in view of Hon'ble Delhi High Court's Order dated 24.09.2012 and 04.12.2012 in WP(C) No. 6439/2011 and 3715/2011.
- 8. The various standing instruction/guidelines/orders regarding various aspects of admission process issued by this Directorate from time to time are reproduced herewith for strict compliance.

#### Schools forcing parents to buy prospectus and charging processing fee.

Buying of prospectus of school along with application form is not mandatory for parents and schools can neither force parents to buy prospectus or charge any processing fee. Only Rs. 25/- (Non-refundable) can be charged as admission registration fee from parents.

ii. Schools following separate admission process for their main school and Montessori/Pre School

The Directorate of Education vide order No. 15702-15871 dated 23.3.99 clarified/ ordered that all Pre-schools/Montessori being run by registered societies/ trusts in Delhi as branches of recognized unaided schools in or outside the school premises shall be deemed as one institution for all purposes, therefore schools have to follow single admission process for their pre - school and main school considering them as one institution.

#### iii. Schools arbitrarily fixing Upper age Limit.

The Directorate of Education vide order No. F./DE/15/1031/ACT/2007/7002 dated 24.11.2007 defined the minimum age for admission in pre –school as minimum of three years by 31st March of the year in which admission is being sought and further explained that the ages stipulated for entry classes are minimum ages and the issue of uniform upper age limit is being deliberated by the Government.

## iv. Schools not giving/accepting forms to/from EWS & Disadvantaged Group applicants who are residing more than 1KM away from school

Directorate of Education vide order dated 13.12.2012 directed that every school shall ensure that the Registration form in the prescribed Proforma are made available free of cost to all applicants under EWS & Disadvantaged without any barrier/hindrance. Schools should accept forms from all applicants under EWS & Disadvantaged group irrespective of distance of residence from school, and then segregate them slab –wise for draw of lots.

#### v. Schools not accepting some valid documents as proof of address.

Some of indicative documents which can be considered as proof of residence of parents / child. (The list is not exhaustive & other documents can also be added by school)

- Ration card issued in the name of parents (Mother/Father having name of child).
- ii) Domicile certificate of child or of his/her parents.
- iii) Voter I-Card (EPIC) of any of the parents.
- iv) Electricity bill/MTNL telephone bill/Water bill/Passport in the name of any of the parents or child.
- v) Aadhaar card/UID card issued in the name of any of the parents.

#### 9. Observers for draw of lots of EWS & Disadvantage Group category.

The Directorate of Education will provide observers for draw of lots of EWS & Disadvantaged Group category like previous years. The instructions in this regards to private recognized unaided schools vide Circular no. F.D.E./15/Act-1/2013/6621-28 dated 22.01.2013 shall be followed strictly (Copy enclosed as Annexure III). However, in view of Hon'ble Delhi High Court's Order dated 24.09.2012 and 04.12.2012 in WP(C) No. 6439/2011 and 3715/2011 the percentage of admission to EWS category students may be read as 20% for unaided minority schools, which have been allotted land by the Govt. Agencies, instead of 10% + 5% as mentioned in para-5 of the said circular.

10. After the closure of admission process on 31/03/2014, each school shall send the details in the form of an undertaking as enclosed at Annexure - IV regarding the number of vacant seats under Economically Weaker Section & Disadvantaged Group to the Chairman of the D.A.M.C./Deputy Director of Education of district concerned by 16.00 hours on 07/04/2014. Simultaneously, the details shall also be provided on the online module available on this Directorate's website. The Chairman of D.A.M.C. /DDE shall take further necessary steps to fill the vacant seats as per the directions contained in sub-clause (d) of Clause 7 of this Directorate's notification No: 15(172)/DE/Act/2010/69 dated 07/01/2011 and Rule 13 of Delhi Right to Education Rules, 2011.



#### CIRCULAR

Instructions for HOS of unaided recognized schools & OBSERVERS appointed by DAMC for each unaided recognized school to oversee the process of admission including "Draw of Lots" for Admissions at the Entry Level for the Year 2013 – 14

- As per Clause 4 (e) of the Notification dated 07/01/2011 issued by the Directorate, "the concerned Deputy Director (Education) shall nominate an officer not below the rank of Vice Principal, who will work as an observer, during the process of admission. The entire proceeding of draw of lots shall be video-graphed and CD/DVD shall be submitted to Dy. Director of Education along with list of successful candidates on the same day or latest by next day of the draw."
- 2. It is the duty of the Head of the unaided recognized School to abide by the provisions of Gazette Notification No. 15 (172) DE/ACT/2010/ 69 dated 07.01.2011 issued by the Directorate of Education, in regard to 'Delhi School Education (Free Seat for Students Belonging to Economically Weaker Sections and Disadvantaged Group) Order 2011'; and subsequent Orders issued from time to time. Observer shall also keep in mind the directions / clarifications contained in the following orders? circulars (copy enclosed)-
  - 1 Notification dated 7 1 2011
  - 2 Circular regarding distance criteria dated 11.2.12
  - Order regarding Admission guidelines for session 2013-14 dated 13.12.12
  - 4 Circular dated 11 1 2013
- School only shall be responsible for any dispute or litigation matter arising out of non-compliance of directions of the Directorate contained in the above-mentioned Orders/Notifications with regard to admission process.
- 4. It shall be the sole responsibility of the Head of the school of unaided recognized schools to categorize applications received for each entry level class strictly as per the Distance Criteria and strictly follow instructions issued vide Circular No. F. 15(11) DE /ACT/2011/7563-74 dated 13/02/2012 and hold Draw of Lots accordingly, if required. Observer will have no role in judging as to whether the distance based categorization is correct or not. It shall be the duty of the Observer to ensure that no sub-division of these categories and/or clubbing of these categories has been done by the school. In this regard Hon'ble High Court of Delhi in its judgment dated 31.01.2012 in WP (c ) No. 636/2012 titled "Federation of Public Schools v/s Govt. Of NCT of Delhi" and WP (c ) No. 40/2012 titled "Federation of Public School v/s Director (Education)" has laid down the following neighbourhood

criteria to the followed by the recognized unaided private schools for admitting children from economically weaker section and disadvantaged group.

- Admission shall first be offered to eligible students belonging to EWS and Disadvantaged Group residing within 1 km. of the specific school.
- In case the vacancies remain unfilled, students residing within 3 km. of the school shall be admitted.
- If there are still vacancies, then the admission shall be offered to other students residing within 6 km. of the institution.
- Students residing beyond 6 km. shall be admitted only in case vacancies remain unfilled even after considering all the students within 6 km. area.
- 5. In case of unaided minority schools who have been allotted land at concessional rates by Govt. agencies, the Hon'ble Delhi High Court vide their interim order dated 30.05.2007 in WP ( C) no.3156/2002 directed such schools to give 10%+5% EWS admission and also devised the distance criteria for giving admission to EWS therefore the admission in such unaided minority schools shall be done strictly as per distance formula devised by the Hon'ble High Court Delhi which is as under
  - (i).Admission shall be first offered to eligible students from proper sections residing within 3 kilometers of the institution.
  - (ii) In case vacancies remain unfilled, students residing within 6 kilometer of the institutions shall be admitted.
  - (iii). Students residing beyond 6 kilometers shall be offered admission only in case the vacancies remain unfilled even after considering all students within 6 kilometers area.
- It shall be the duty of the Observer to ensure that no sub-division of these categories and/or clubbing of these categories has been done by the school.
- The Heads of Schools shall inform by way of a notice to parents/guardians of eligible students about the specified date and time on which the draw of lots is fixed for; to be held in the presence of the OBSERVER.
- 8. The OBSERVER of the DAMC is authorized to scrutinize any relevant records of the school related to the admission and has the right to take copies of any relevant documents including details of children as per requirement, duly signed by the Head of the assigned Recognized Un-aided Public School.

- 9. The issue of minimum age of admission has been again clarified vide circular dated 11.1.2013. Till the time the government decides to put a uniform upper age limit (which is under consideration), the concerned school shall be fully responsible for the decision school has taken in respect of upper age limit. The observer will have no responsibility in this regard.
- 10.If the OBSERVER finds that the school is ignoring any of the provisions of the Notification dated 07.01.2011 and Order Dated 13-12-2012 of the Directorate of Education and/or is involved in any unfair practice, an appropriate report specifying the violations is to be furnished in writing to the DAMC Chairperson.
