In case of any discrepancy with respect to any Laboratory Assistant (newly promoted) is found, the matter may be referred (with attested copies of documents) through proper channel to E-IV Branch and such officials may not be relieved till receipt of clarification from Head Quarters /E-IV Branch.

If any official does not accept promotion, no fresh offer of promotion will be made to him / her for a period of one year from the date of refusal of such promotion or till the next vacancy occurs, whichever is later. If the reasons adduced by the official for his / her refusal for promotion are not acceptable to the Appointing Authority, it may enforce the promotion of the teachers concerned. Any teachers refusing promotion and debarred consequently will lose his / her original seniority, when he / she is promoted later. He/she has to apply afresh for inclusion of his /her name in Eligibility List.

After checking the eligibility as per recruitment rules and obtaining fresh Vigilance Clearance report in DDEs office, the promotion-cum-posting orders of the Laboratory Assistants will be issued online through MIS by this Branch on receipt of report fromall DDEs / branch in charges regarding verification of all documents of promoted officials in respect of their districts / branches. A module has been prepared for this and it can be accessed through the password of District DDEs in link of transfer procedure.

District DDEs may log on the MIS through their password and ensure that the fresh Vigilance Clearance Report is available and SC/ST Certificates (Whereever applicable) and requisite qualification as per RRs with reference to cut-off date are in order as per rules. Thereafter, necessary certificates may be issued through MIS and hard copy of the same may also be sent to the District where the concerned Laboratory Assistant has been posted on promotion. It should be kept on record, if the Laboratory Assistant concerned is posted in the same District.

After receipt of hard copy of Vigilance Clearance Report etc. the District DDEs where the Laboratory Assistant has been posted on promotion, will log on the MIS through their password and issue Posting Orders and will also send a hard copy of the Posting Orders to the concerned Principal wherever the Laboratory Assistant is posted on prior to promotion.

After receipt of hard copy of the Posting Order the Principal concerned will generate the Relieving Order through MIS only and send the hard copy of the Relieving Order to the Principal where the Laboratory Assistant has been posted on promoted.

On receipt of hard copy of Relieving Order the Principal concerned will generate the joining through MIS. In no case, the Laboratory Assistant should be relieved without obtaining a hard copy of Posting Orders from the DDEs where the Laboratory Assistant has been posted on promotion. The concerned Laboratory Assistant should not report to the new place of posting without Relieving Order through the MIS from the present place of posting.

It shall be personal responsibility of the ADE (Admn.) and Supdt. (Admn.) of the District to ensure that all documents are checked on or before 25.01.2013. Any lapse in this regard will be viewed seriously. It is further directed to submit the on-line employee details of promoted Group 'D' employees (Generated by MIS alongwith their nearest school with Code) to E-IV Branch urgently.

The cut off date for acquiring requisite qualifications as per RRs is 01.01.2011. It may be ensured that the employees has not possessed essential qualification after 01.01.2011. The above information must be forwarded to Establishment-IV Branch on or before 25.01.2013.
