MINUTES OF EWS&DG DAMC MEETING HELD ON 14/01/2013

This District office was in receipt of various applications from the parents even after closure of admission process as per schedule declared by the Directorate of Education for the session 2012-13 requesting for grant of permission for admission of their children under EWS and Disadvantageous Group as they could not get admission in any school inspite of submitting applications in various private unaided recognized schools. These applicants were approaching the DAMC of the District office both individually and through representatives (Justice for All) to consider their applications against the seats which were still vacant in many schools. But this District office was not able to consider their requests in the absence of guidelines to be followed while filling up the vacant seats under EWS&DG at such a late stage.

The above issue was raised by the DDE (NW-B) several times in the meetings held in Directorate of Education and a file was also moved to the HQ seeking clarification whether the children can still be admitted under EWS&DG and what guidelines are to be followed while filling up the vacant seats still available in various private unaided recognized schools of this District, so as to avoid any future litigation as many parents were threatening to approach the court for redressal:

Now, it has been clarified by the Director of Education vide UO No. 11650/DE dated 18/12/12 that "the list of vacancy at entry levels be compiled at DDE level, be put on notice board of DDE office and department website and after giving some time, existing and new applications so received needs to be appropriately dealt with."

In pursuance of the above clarification, a NOTICE was displayed on the notice board of this District office on 28/12/2012 along with vacancy position supplied by EO Zone XI, XII and XIII under EWS&DG inviting representations in the matter by 05/01/2013. Further vacancy position under EWS&DG has also been uploaded on the department website on 09-01-2013.

In view of the above, a Committee was constituted consisting of the following members in pursuance of Addl. Secretary of Education (Admn.) Notification dated 07-01-2011 to examine the applications under EWS&DG for their allotment to various private unaided recognized schools where vacancies for Pre school, Pre-Primary and Ist Class still exist :-

The meeting of the said committee was held on 14/01/2013 at 2:00 P.M. and with the discussion, it has been decided as under:-

- The cases in which applicants have requested for admission of their children in a particular school, the same school has been allotted to the applicants if there is a vacant seat in that school. In case vacancy is not available in that particular school, the nearer school has been allotted to the applicant.
- The cases in which applicant have requested for admission of their children in **any school** near to their residence, the nearer school has been allotted to the applicants.
- However, no verification of documents like age proof, income certificate, caste certificate, residence proof etc. has been made by the DAMC. Hence it shall be the sole responsibility of the allotted private unaided recognized school to verify the said documents and to complete all formalities before giving admission to the applicants.** In case any applicant is not able to produce the required documents and as a result the case is rejected by the school concerned, the school will issue a speaking Rejection Order in the matter to the applicant after taking approval of DAMC.
- Besides private unaided recognized school shall make arrangements of special training to help the children in completing the studies *as per provisions of Rule 13 of Notification dated 23/11/2011 in respect of RTE Act, 2009.*
- It shall be the sole responsibility of the concerned EO to inform the applicant about the allotted school within Five days.
- After giving admission to the applicants, the concerned private unaided recognized school will furnish the compliance report to the Chairperson, DAMC as well as to the concerned EO.
