**1. Qualification:-**

Post Graduate in Maths, English and Science (Phy./Chem./Bot./Zool.) with Degree in Education and 05 year teaching experience in recognized school/organization. The experience certificate must be countersigned by the competent authority.

OR

Master in Maths, English and Science with M.Ed. or Equivalent

**Note:-** 1. Candidate having less than 05 years experience and have not done B.Ed. will not be considered

2. Candidate who have qualified M.Ed. will be exempted from the requirement of experience.

2. **Age:-** Maximum 45 years as on 31.01.2013.

3. **Tenure:-** One year (which can be extended further as per requirement)

4. **Emolument:-** Consolidated remuneration of Rs. 23870/- per month.

5. **Mode of Selection:-** The Candidates possessing the requisite qualification may submit their applications **online** in the prescribed format and **online** subject wise merit list will be prepared for the three subjects.
6. **Nature of duties:-** The Resource Persons should be academically sound. They should be in a position to plan and provide need based academic resource support. They will also provide all teachers teaching at the elementary education stage in school. Further to plan and organize workshops for academic development of teachers and all necessary work relates to planning and implementation of SSA interventions and to take supervision and monitoring work as assigned.

1. The candidates so engaged on contract basis shall not claim for regular appointment in the UEE Mission or Directorate of Education.
2. The candidates so engaged on contract basis shall not file any court case regarding salary and regularization.
3. The selected candidates will have to sign a contract agreement with UEE Mission and in case of breach of contract, the same will be cancelled without giving any notice.
4. Selected candidates will have to join their duties, immediately, after getting the engagement letter and in case of non-reporting for duty during the stipulated period, next candidate available in the merit list will given the offer, no formal intimation or letter for cancellation of the offer will be sent to the candidates in this regard.
5. No application will be entertained after the due date.
6. No application will be accepted in person or courier.
