CIRCULAR

Hon'ble High Court vide their order dated 08-08-2012 in W.P.(C) No. 7814/2011 titled COURT ON ITS OWN MOTION versus RAJKIYE UCHCH MADYAMIK BAL VIDYALAYA AND ORS, directed as under :-

"Once Rule 38 of the Rules provides for the School to have a Medical Officer on part-time or full-time basis and the Medical Crisis Management Committee has also emphasized for the same, appropriate steps would be for the schools to have such medical practitioners along with paramedic in terms of the Rules. The respondent is directed to implement Rules 38 of Delhi School Education Rules within six months."

The provisions of Rule 38 of Delhi School Education Rules, 1973, stipulate as under:-

"Medical Officer – (1) Every recognized school shall appoint a Medical Officer on such part-time or whole-time basis as may be necessary for looking after the health of children of the school.

2. The Medical Officer shall be assisted by such Compounder or Dispenser on a part-time or whole-time basis, as may be necessary.
3. In the case of girls' schools, only lady doctors and lady compounders or nurse shall be appointed.
4. In the case of co-educational schools, not less than one lady doctor or female nurse shall be appointed."

Therefore, the managements of all recognized unaided schools of Delhi are hereby directed to comply with the provisions of Rule 38 of Delhi School Education Rules, 1973 and submit compliance report in their respective zonal office and fill the on-line module as well within one month's time.

Non-compliance of the order would be viewed seriously.
