## NOTIFICATION

- 1. Short title and commencement- (i) This Order may be called the Delhi School Education (Free Seats for students belonging to Economically Weaker Sections and Disadvantaged Group) Amendment Order, 2013.
  - (ii) It shall come into force with immediate effect.
- 2. In Clause 3 for sub-clause (a), the following clauses shall be substituted, namely:-
- (a) "All schools shall admit children in class one to the extent of at least twenty-five percent of the strength of that class, children belonging to weaker sections and disadvantaged groups in neighborhood and provide free and compulsory elementary education till its completion.

Cont...2...

Provided that where such school imparts pre-school education, the provisions shall apply for admission to such pre-school education:

Notwithstanding supersession of order no. F.DE/15/ACT/2006/424 adated **25.01.2007** the school (including minority) which were allotted land by the government shall also admit children from economically weaker section in neighborhood to the extent of ten percent and five percent for the wards of the employee of the school in all fresh admissions made in other classes above the entry level till the operation of the interim order dated 30.05.2007 of the Hon'ble Delhi High Court in WPC No. 3422/2007 and the connected petitions or till the final outcome of these petitions.

Provided that the above provisions of 15% admission shall also be applicable at entry level for minority schools which were allotted land by the government agency."

3. After clause 3 (a) a new clause (aa) shall be inserted, namely:-

"3(aa) The students admitted against twenty five percent free seats under the provisions of Free and Compulsory Elementary Education shall get financial assistance at par with students of Government School, for expenditure on account of uniform and books. The financial assistance shall be reimbursed by education Department and disbursed through the Head of the School."

- 4. In Clause 6 in sub clause (c) following entry, after entry (iv) shall be inserted, namely:-
  - "(v) Aadhhar Card/ unique identification card (UID) of child/any of the Parent."
