PUBLIC NOTICE

Sub: Engagement of Guest Teachers in Schools of Directorate of Education.

Guest Teachers are proposed to be engaged in respect of **PGT/Lecturer (EVGCs) and Special Education Teacher (TGT)** by the Heads of Schools of the Directorate of Education from amongst the qualified youth. The Guest Teacher shall be engaged purely on temporary basis, till the post is filled up on regular basis or till 10th May, 2014, whichever is earlier. Willing candidates may register themselves with any one specific school of choice online on our website www.edudel.nic.in from **15th July, 2013 to 24th July, 2013**. **Candidates who have already applied *online* in response to the advertisement released in leading news papers by this Directorate dated 26th June, 2013 for these two posts are advised to apply again**. The details of eligibility are as under:-

1. PGT/Lecturer (EVGCs):

- (i) M.A. in Psychology from a recognized University.
- (ii) Degree or Diploma in Guidance and Counseling.

2. Special Education Teacher : (TGT) (for Physically Handicapped, Speech Impaired, Mentally Retarded and Partially Sighted):

- (i) Graduate.
- (ii) B.Ed (Special Education) **OR** B.ED with two years diploma in special education **OR** post-graduate professional diploma in special education.
- (iii) Qualified CTET.

3. Age Limits :- As on 1st July, 2013

(i) Special Education Teacher (TGT) : Not exceeding 30 years
(40 years for female)

(ii) PGTs/EVGCs : Not exceeding 36 years

4. Guest teacher would be engaged on the basis of academic merit. However, marks obtained in CTET will not be considered for purpose of determination of merit.

5. The Guest Teachers shall be paid as per the rates mentioned in the following table which have been approved by Finance Department vide U.O. No.54/DS3 dated 19-6-13 :-

6. The candidate shall fill-up his/ her name, as appeared in the certificate of class X examination. Any deviation in this regard will lead to disqualification. Candidates in their own interest are advised to fill up all the items in the online application form carefully. Before submitting the form online he/she shall check the particulars on the "Review" screen. Requests for correction what so ever shall not be entertained at later stages.

7. **The candidate shall use, internet explorer only while filling up application online.**

8. The order of merit list will be displayed on website on **27/07/2013** and Candidates are accordingly advised to contact the HOS concerned immediately.
