for entry at Sr. No. 115, the following entry shall be substituted, namely:-

- "115.(i) W.e.f.11.05.2005 to 10.06.2013: Spectacles, Sunglasses, parts and components thereof, contact lens and lens cleaner" and
 - "(ii)W.e.f.11/06/2013: Spectacles, parts and components thereof, contact lens and lens cleaner but not including Sunglasses, its parts and components."

This notification shall come into force with effect from the aforementioned dates.
