
**CIRCULAR**

References are being received from various Hospitals of the Govt. of NCT of Delhi seeking clarification regarding benefits to be provided to Non-Teaching Specialists and GDMOs who have been appointed in the initial constitution of Delhi Health Services under Rule 6(2) of the Delhi Health Services (Allopathy) Rules, 2009, vide this Department Order No. F.70/49/2006/H & FW/Vol.IV/Part File/2670-2700 dated 15/05/2012.

As per Rule 14 (1) of Delhi Health Services (Allopathy) Rules, 2009 the conditions of service of the members in respect of matters not expressly provided for in these rules, shall, mutatis mutandis and subject to any special orders issued by the Government in respect of the said Service, be the same as those applicable to officers of the Central Civil Services in general.

Since above-mentioned doctors are regular government servants as of date, all benefits of regular employee under DHS (Allopathy) Rules, 2009 shall be applicable in the year 2013 and thereafter, to 318 GDMOs and 204 Specialists, appointed under the initial constitution clause of the Delhi Health Services vide this Department's order dated 15/05/2012. The decision with regard to the date of appointment of the said doctors in the cadre will be taken separately by the Competent Authority, and this communication is without prejudice to the same.

All Directors/MSs/HODs may take action accordingly.


