The CNG converted "In-use" base model "**Getz GLS" 1341cc (September 2005 make) Fitted with O.E. Catalytic Converter**", meets the Bharat Stage-III norms. Same kit can therefore be fitted on the MPFI vehicles fitted with O.E. Catalytic Converter, between stipulated Engine cc range (1005.75 to 1676.25cm<sup>3</sup>) manufactured / registered from 1<sup>st</sup> January 2005 till the validity of Bharat Stage III norms, subject to specific approval, for layout plan by ICAT, for retrofitment of CNG kit in each vehicle model.

2. All conditions and compliance requirements, in respect retrofitment of CNG kit, given in the certificates referred above, remain unchanged

Kit Manufacturer / Supplier/ Distributor is directed to ensure the strict compliance of CMV Rule 1989, as amended up to date & retro fitment should be carryout at the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components, parts/assemblies etc. which were produced before testing agencies before submission of the vehicle for alteration.

All MLOs / Registering Authorities shall at the time of registration, verify the CCoE approval for the CNG cylinder and cylinder valve, in respect of documental reference for quantity/Sr.No. cleared by DoE from time to time. Further, it should also be ensured that the retro fitment, terms & condition and validity given in the type approval certificate as mentioned above and to accept endorsement of Gas Kit on the Registration Certificate subject to fulfillment of provisions of Motor Vehicle Act, 1988, and Rule made their under the department instructions / order issued from time to time in this regard.
