- ❖ **Gender Sensitisation** : A one-day training programme on 'Gender Sensitization' is to be held on **05.07.2013**. The above said training programme focuses on creating General Awareness about Gender Sensitization, relating mainly to the girl children's survival, nutrition, mortality and neglect in all phases of life. The above said programme is also sensitize people about Gender bias and discrimination against girl child is a global phenomenon that may occur before birth and continue beyond childhood into adulthood. Girl children are exposed to discrimination and violence in all settings, often in places where they should be most protected i.e. in their home, school or even immediate community. **Nominations to be sent latest by 28.06.2013**
- ❖ **Rights and Welfare of Persons with Disabilities**: A One day training programme on 'General Awareness about Rights and Welfare of persons with Disabilities' is to be held on **12.07.2013**. Persons with disabilities are valuable human resources. Their disabilities are not the handicaps in their participation in affairs of the society and contribution to it. The National Policy for Persons with Disabilities focuses on this aspect of an important social issue. Government of India has framed The Persons with Disabilities (Equal Opportunities, Protection of Rights, and Full Participation) Rules, 1996 and other rules and regulations. There is need for general awareness of the Act, rules, and guidelines. **Nominations to be sent latest by 05.07.2013.**
- ❖ **Consumer Rights**: A one-day training programme on 'General Awareness about Consumer Rights' is to be held on **19.07.2013**. The above said training programme focuses on Rights and protection of the consumer who have become an important issue in era of free market economy and liberalization. Awareness of consumer rights helps building up an atmosphere of ethical business tradition and guard against unfair business activities, frauds, misrepresentation etc. The course is designed to create consumer awareness and develop a strong consumer protection movement. **Nominations to be sent latest by 12.07.2013.**

It is requested that 4-5 suitable **officers / officials** may be nominated to participate in these courses. The nominations should be sent in time for each course.


