It is reiterated for the information of all concerned that wherever a vigilance complaint or a reference is made by Directorate of Vigilance/Central Vigilance Commission for report or the comments same need to be submitted to the referring authority and under no circumstances, the same can be closed or disposed off by the concerned Head of Department or Head of Autonomous Body.

With a view to streamline system of disposal of complaints/reference made by DOV/CVC, it has been decided that henceforth no reference of this nature shall be disposed off by the concerned department or the autonomous body at their own and desired reports/comments shall be sent to DOV/CVC. In case of non-compliance, the concerned official shall be liable for disciplinary action as deemed fit in the matter.
