

CIRCULAR

Sub : Allotment of Delhi Govt. General Pool Residential Accommodation through an Automated System of Allotment based on choices for specific houses indicated by the applicants – Initiation of Online Bidding for houses in the AUTOMATED SYSTEM OF ALLOTMENT (ASA) with effect from July 2014.

In continuation of this office O.M dated 28.02.2014 & 23.04.2014 on the subject cited above, it is hereby informed that in order to enable more applicants, both new applicants as well as those already registered, get their Login ID and Password activated to access the new on-line system of bidding for houses , the allotment of Type I to Type IV houses had been deferred.

All the applicants are hereby further informed that the online system of allotment would now become functional (for bidding of houses) with effect from July 2014. Hence both new applicants as well as old applicants are required to get their Login ID and Password activated at the earliest. The bidding for houses (Type IV) would be open from 14th to 28th of July 2014. The Automated System of Allotment(ASA) would begin initially for Type IV and thereafter ASA (online bidding) will be followed in other categories in the subsequent months(August 2014 onwards). It is requested that all staff members under the control of respective HODs may be informed accordingly about the same.
