CIRCULAR

In pursuance of this appeal by Hon'ble Lieutenant Governor, all departments are hereby directed to ensure that their properties are free from any sort of defacement. They must put a system in place to ensure that firstly, no one puts such posters or is able to deface their property and secondly, if any such defacement is found, it is immediately removed and the persons responsible for such defacement are traced immediately and necessary legal action against such persons be taken by filing an FIR under prevention of Defacement of Public Property Act.
