Sub: **Regarding exemption of water tankers and sewer cleaning machines for plying in "No Entry" areas and Police arrangements at critical water emergency control rooms.**

The above matter was taken up with Delhi Traffic Police deptt. The request of DJB has been acceded to. In this regard all CEs are requested to circulate enclosed copy of the letter dt. 04.04.2014 received from Spl. Commissioner of Police (Traffic) confirming that DJB water tankers and sewer cleaning machines engaged in maintaining essential services do not require "No Entry Permission" for plying during the restricted hrs. At the same time all these vehicle will strictly follow other traffic rules.

Instructions have also been issued to the police stations to provide police protection to DJB staff manning critical water emergency control rooms. Copies of the above letter be given to all the tanker operators & drivers to carry it with the vehicles on duty.



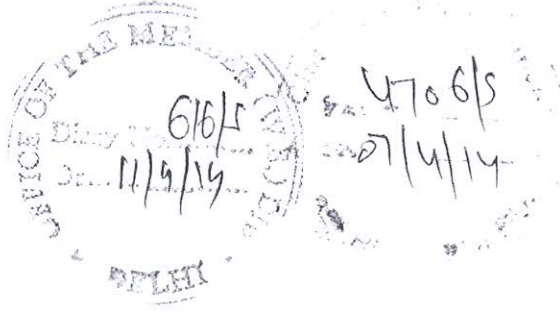

Dear Sh Vyay kumar,

Please refer to your D.O. letter No. CEO/DJB/2014/691 dated 25.03.2014 and D.O. letter No. F-53/DJB/M(WS)/2013/627 dated 11.03.2014 regarding exemption of water tankers, trailer tankers, tractors trailers and sewer cleaning machines for plying in 'No Entry' areas for the supply of water and the disposal of sewage during this summer season.

Delhi Traffic Police has already exempted vehicle mounted water tankers of Delhi Jal Board and water tankers operated by private operators on behalf of Delhi Jal Board to ply in specific 'No Entry' areas. They do not require 'No Entry Permission' for plying during the restricted hours. Instructions in this regard have already been issued to all field officers. In addition, 'Sewer Cleaning Machines' and 'Jetting-cum-Suction Machines' engaged by Delhi Jal Board are also allowed to ply during the restricted hours and as such they do not require 'No Entry Permission'.

Water tankers towed by tractors cannot be allowed to operate on the main roads. It may be added that tractors severely impede the flow of traffic, and increase the risk of accidents particularly when a loaded trolley/tanker is attached to a tractor. However, in view of the requirement of essential service, Delhi Police is ready to give 'No Entry Permission' to tractor driven tankers provided they are used within the interior roads of a colony as a last mile connectivity, and vehicle mounted tankers are brought to such colony to fill in the tankers to be towed by tractors. This suggestion had also been approved by the Hon'ble L.G. Delhi when the issue came for discussion in the law and order meeting at Raj Niwas on 27.03.2014. Delhi Jal Board may chalk out their route and inform Delhi Police for issuing 'No Entry Permission' for a mutually agreed area. Delhi Police officers have already contacted your office in this regard for an early decision.

Instructions are being issued to the respective police stations to provide necessary protection at the identified 8 critical water emergency/control room/filling points/locations which are prone to manhandling of DJB staff by local residents and anti-social elements.
