1. Sh.S.K.Srivastava, Chief Secretary, Government of NCT of Delhi has been appraised of the subject matter for which his personal presence was required in Court today.

2. He states that by-weekly meetings of the Committee headed by Professor A.K.Gosain are being held, but concedes that the same are not being minuted.

3. We are of the opinion that minutes of each meeting should be minuted for the reason we find that Profesor A.K.Gosain has been sending communications to the Joint Secretary, Urban Development, Government of NCT of Delhi on the subject of not receiving necessary information from the different wings of the Government of NCT of Delhi.

4. Sh.S.K.Srivatsava, Chief Secretary, Government of NCT of Delhi assures that full co-operation would be provided by every department and wing of the Government of NCT of Delhi to Professor A.K.Gosain so that the directions issued on October 29, 2013 by this Court can be given effect to. He assures that the Joint Secretary, Urban Development, Government of NCT of Delhi shall co-ordinate sharing of information and data and response, if any, to be given to Profesor A.K.Gosain.

5. Taking on record the assurance and hoping that by the next date a report will be submitted to this Court complying with the directions issued by this Court on October 29, 2013, we defer hearing in the writ petition.
