Sub: Installation of water meters in DJB staff quarters from Type-V and above

Section 17(1) of Delhi Water Board Act, 1998 provides that " the Board may provide water meters to measure the consumption of water by any person using water supply for the Board and, until the contrary is proved, it shall be presumed that the quantity of water shown by the meter has been consumed."

In a meeting chaired by the CEO on 11.7.2014, it was duly emphasized to enforce accountability of DJB water. It was further accordingly decided to start individual billing of water connections installed in Type-V and above DJB quarters and further ask the Engineering Wing to install latest water meters on these water connections so that individual occupiers of Type-V and above DJB quarters are billed as per their actual consumption of water.

The concerned Engineering Wing Officers (W/S/R)/ZROs are accordingly informed to allocate individual water connection numbers to the concerned officers under RMS so as to initiate individual billing. Similarly, officers under the overall control of Chief Engineer (Project)Water will obtain list of all Type-V and above DJB quarters from Asstt. Commissioner (L&E) including names of the occupants and install functional water meters through the designated agencies under intimation to the concerned Zonal Revenue Officer so that individual billing in each case could be commenced at the earliest. While installing water meters, it may be ensured by all concerned that date of installation of water meter is duly entered against specific K.No. in the RMS. As desired by CEO, this exercise has to be necessarily completed within 15 days of the date of issue of this letter, which may please be noted.
