**SHOW CAUSE NOTICE**

**Whereas,** pursuant of the recommendations of the Justice Usha Mehra Commission report and the decisions taken by the Special Task Force Constituted under the Chairmanship of Union Home Secretary, all the schools ( Govt./Aided/Un-aided) were directed, vide this office circular No. DE. 15(143)/Act-I/Tpt/2013/6320-32 dated 04.01.2013, that before hiring chartered buses for their schools they must ensure that only those drivers/staff have been deployed in these buses whose character and antecedent have been verified by the Police.

**Whereas,** schools (Govt./Aided/Un-aided), vide Order No. DE.15(330)/Act-I/2013/11649-11662 dated 12.11.2013, were again directed to submit a Certificate cum Undertaking in annexure 'A' or 'B' (whichever is applicable) to their respective zonal officers of the Directorate with regard to verification, by the police authority, character and antecedent of drivers/staff deployed on buses hired as well as owned by the schools within 10 days.

**Whereas,** reminders from time to time have been issued to schools to submit the above said Certificate cum Undertaking but till date following nine schools have not submitted the above said Certificate cum Undertaking:-
