## CIRCULAR

Sub: Instructions for Online Admissions in Class XI in Science and Commerce Streams for the Session 2014-15.

This is in continuation of our earlier Circular no.DE.23(28)/Sch.Br./08/257 dated 20/03/2014. The admissions for class XI in the Science & Commerce streams will be done online for the year 2014-15 as per the Admission Plan submitted by the concerned zones.

#### A. ADMISSION PROCEDURE for Govt./Govt. Feeder Schools

- Registrations of the students will be done in their OWN/FEEDER SCHOOL. Each student has to compulsorily fill and submit the OPTION FORM (Annexure -1) in the school from where he/she appeared in class X exam.
- It is the <u>responsibility of the HOS</u> to ensure that all students submit the <u>option</u> form in their <u>own</u> school.
- HOS will submit online the names of those eligible students who have opted for Science/Commerce stream.
- A merit list (ML-1a, ML-1b) for Govt. /Govt. Feeder schools will be generated online and the same will be displayed by the HOS of own/feeder school as per schedule mentioned in the circular.
- In case, the number of students who have applied for Science/Commerce stream
  is more than the seats available in the particular school, another school will be
  allotted by the E.O at Zonal level in the online module. The name of the allotted
  school will be reflected in the own/feeder school as well as in the allotted school
  where the admission will be given to the students as per {ML-1(a)}. In such cases
  the students will contact the "Allotted School" (where admission is to be done)
  for admission.

Feeder schools will forward the S.L.Cs of plan scheme students (ML-1a, ML-1b) to the concerned allotted school within ten days of the declaration of the respective merit lists.

# B. ADMISSION PROCEDURE (Manual) for Govt. Aided / Feeder Private /Recognized Private / Other Schools.

All the Heads of Govt. schools are directed to adhere to the following instructions in letter and spirit while preparing the merit list for the following categories of students:

- Govt. Aided school students.
- Feeder Pvt. School students as per Admission Plan.
- Public School Students/Outside Students.
- Application forms for such Admissions are to be filled and submitted by the students directly in the school where they seek admission.
- The merit lists for Science and Commerce streams will be prepared separately as ML-2 for students of Govt. Aided schools, ML-3 for Feeder Private School students as per admission plan and ML-4 for students of Other Schools.
- The merit lists ML-2, ML-3, ML-4 will be prepared separately for each stream as per the criteria given in the circular dated 20/03/2014.
- 4. The Heads of Schools must ensure that first of all, the eligible students of ML-1a & ML-1b shall be given admission in the Science and Commerce streams as per the merit list of "Own/Feeder Govt. School students". Only after all the students of ML-1a, ML-1b have been admitted, then the HOS will consider ML-2 and thereafter ML-3 and then ML-4.
- Importantly, admissions will be given to ML-2 i.e. Govt. Aided School students only if seats are vacant after giving admissions to Govt. school students of ML-1a & ML-1b.
- 6. If seats are still available, then admissions will be given to Feeder Private School Students as per admission plan (ML-3) and thereafter, Public School / outside students (ML-4) in strict order of merit list. The CBSE / Concerned Board roll numbers of such students must be mentioned in the merit list and grades of the concerned students must be properly checked and verified by the Head of School. In order to observe transparency in admission procedure, Heads of schools are hereby directed to prepare Merit lists 2, 3 & 4 for Science and Commerce Streams

by taking into account all applications received in the school. In addition to above, the following instructions should also be complied with:

- Prepare the merit lists including CGPA & Grade points of their required subjects (as per circular no.DE.23(28)/Sch.Br/08/606 dated 28/05/2012).
- The HOS has to prepare the merit list according to these total grade points keeping
  in view that a student must have obtained minimum qualifying grades in each
  subject as per admission criteria for Science and Commerce streams.
- It is also important to note that just <u>getting minimum qualifying grade & CGPA</u> does not guarantee admission in a particular stream.
- The Education Officers are also directed to monitor the admission process personally and closely and it is their responsibility to ensure that no rules are violated. Transparency is to be maintained at all levels.
- HOSs must ensure compliance of circular no. DE.23(28)/Sch.Br/865 dated 02/07/2013 and circular no. DE.23(28)/Sch.Br/08/606 dated 28/05/2012).

The HOSs are directed not to force the students of their own school to choose a particular stream. All the eligible students of their own school must be given the stream of the students' choice, subject to merit and availability of seats.
