The respondents have handed over a copy of a Circular 27.05.2014 requiring the private unrecognized schools to ApVE

Court Master High Court of Delhi New Delhi compliance report as to whether its previous Circular was implemented with respect to reservation of two seats for children with special needs in the pre-nursery and nursery classes for academic year 2014-15, i.e., at the entry level. The said Circular is hereby taken on record.

This Court is unsatisfied with the nature of response and the implementation of its judgment for academic year 2014-15. However, before passing any final orders in the pending proceedings or *suo motu* contempt initiated, the respondents/GNCTD are hereby directed to file a comprehensive affidavit: -

- (i) indicating names of the schools, names of the children with special needs, with the nature of disability, who have been admitted at the entry level (pre-nursery and nursery level) for academic year 2014-15. This shall be split up in separate charts indicating which amongst such students were admitted to the schools operated by the GNCTD, MCD and local authorities and which of the students were admitted either in the 25% quota or the unreserved quota amongst unaided private schools;
- (ii)indicating steps taken in regard to the implementation of the previous judgment of this Court in Social Jurist A Civil Right Group v. GNCTD, W.P.(C) 4618/2011 decided on 5.9.2012. This shall not be merely confined to the copies of Circulars issued by the GNCTD to all the schools which fall in the jurisdiction, but also the steps taken by each school for appointment of special educators and creation c

Court Master High Court of Delhi New Delhi educational facilities in such schools - including unaided schools to accommodate the children with special needs.

The affidavit shall be filed within four weeks.

The Govt. of NCT of Delhi shall issue a public notice/Circular and advertise it, calling for information from parents of children with special needs who could not be admitted for academic year 2014-15 at entry level (pre-nursery and nursery) and ensuring their admission.
