In partial modification of this Department's Order NO.DE.15/Act-I/08/155/24829-24840 dated 08-07-2014 and Public Notice dated 08-07-2014, the different dates mentioned in the order may be read as under:-

5. In para 6 (O), the date of furnishing the information to the district office as well as on the website of the department by the schools in respect of vacant seats under EWS/DG Category - 14-07-2014 instead of 09-07-2014.
