CIRCULAR

Attention of all the HOS/Managers of Private Unaided Recognized Schools is hereby invited towards the Circulars/orders issued by this department from time to time with regards to transport facilities provided by them to ferry school children.

Ministry of Home Affairs, Government of India is regularly monitoring, steps taken for women and public safety after the incident of December, 2012.

Some of the such measures, were to be taken are to get GPS installed in all school buses, verification of the antecedents of drivers and conductors, to up load the list of drivers and conductors of the chartered buses hired by the schools on the website of the Education Department etc. In this regard the following actions are required immediately:-

- (i) To ensure that all school buses have GPS system installed.
- (ii) To provide the details of school buses, which have got the GPS installed.
- (iii) To ensure 100% verification of drivers and conductors engaged in school buses.
- (iv) To provide the details of CC buses/chartered buses engaged by the schools or arranged by the parents for transportation of students/children and to ensure that these buses have GPS installed and have got verified the antecedents of drivers and conductors.
- (v) To upload all the details of school buses (school owned, chartered and arranged by parents) and bus staff on the Education Departments's website.

All the Heads of Schools/Managers of Private Unaided Recognized Schools are hereby directed accordingly to take the following steps immediately:-

- (i) To ensure that all the buses owned by the school, hired by the school or arranged by the parents to ferry school children have GPS system installed.
- (ii) To provide the information with regards to detail of buses owned by the school, hired by the school or arranged by the parents, which have got the GPS installed, to their respective zonal office of Education Department with in 15 days positively to submit the information in next review meeting.
- (iii) To submit a certificate in their respective zonal office of Education Department that the 100% verification of drivers and conductors engaged in school buses owned by the school, hired by the school or arranged by the parents is completed.

- (iv) To upload all the details of school buses (school owned, chartered and arranged by parents) and bus staff on the Education Departments's website.

All the DDEs are hereby directed to take up the matter with school managements of Private Unaided Recognized Schools falling under their respective jurisdictions to do the needful and submit the compiled report in this regard to this branch immediately after receipt of the same from the managements of the schools.

This issues with the approval of competent authority.
