Subject: Reminder for realizing II installment of Ad-hoc Payment from unaided & recognized schools .

Sir/Madam,

In compliance of order No. 24661-24667, dated: 30/06/2014, on the subject cited above only 109 Private schools have responded out of 1300(+) schools till the last date 18/07/2014 as per on line data available in ACT-1 branch.

It is worth mentioning here that in pursuance of order of dated 01/12/2012 of Hon'ble High Court in WP© 7777/2009 titled "**Abibhavak Mahasangh & Ors. Versus Govt. of NCT of Delhi & others**", the 90% of the fee and expenses of the Justice Anil Dev Singh Committee is to be borne by the all unaided and recognized schools.

Therefore all Deputy Directors of all Districts are directed to expedite this matter on **priority and urgent basis** by directing all the remaining Private schools to remit the Ad-hoc payment of the second installment within three days from the date of issue of this order.

Education Officers are also instructed to submit all the collected Bank Drafts /Pay orders issued in favour of **Account Officer (Cash) Directorate of Education (HQ) along with the hardcopy of the zonal level online report by 31/07/2014 to AO (Cash) Head Quarter directly. No Draft will be accepted at HQ level directly.**

**ORDER**

**WHEREAS** in pursuance of the orders dated 12.08.2011 of Hon'ble High Court in WP@ 7777/2009 titled "Abibhavak Mahasangh & Ors. Versus Govt. of NCT of Delhi & others " a three member committee headed by Justice Anil Dev Singh , Chief Justice (Retd.) Hon' ble High Court Rajasthan was constituted vide notification No. 15(110)/DE/Act/201/5426-38 dated 23.09.2011 issued by Directorate of Education.

**AND WHEREAS** Hon'ble High Court of Delhi vide its order dated 03/10/2011 has fixed per sitting fee of Rs.50000/- of Justice Anil Dev Singh, Chief Justice (Retd.) Hon' ble High Court Rajasthan, Rs. 25000/- of Mr. J.S.Kochar, Chartered Accountant and Rs. 25000/- of Dr. R.K.Sharma, Retired Additional Director of Education.

**AND WHEREAS** in pursuance of order of Hon'ble High Court Delhi dated 03/10/2011 an order was passed by Directorate of Education vide No.4812-18 dated 10.10.12 directing Managers/ Head of Schools of all the unaided recognised schools to make an ad-hoc payment of Rs.14000/- (Rupees fourteen thousand only) to meet 90% of the fee and expenses of the committee.

**AND WHEREAS** in continuation of aforesaid mentioned order of 10.10.2012, second order No. 6711-16, dated: 29/01/2013 was issued wherein the ad-hoc share was reworked to Rs.9000/- (Rupees nine thousand only) assuming that the committee functions till June 2013. Managers /Head of Schools that have not made ad-hoc payment Rs. 14000/- till 29/01/2013, were directed to pay only Rs. 9000/- as the ad-hoc payment to meet 90% of the fees of the committee.

**AND WHEREAS** in pursuance of order of Hon'ble High Court, Delhi , dated: 09.05.2014 the tenure of Justice Anil Dev Singh Committee has been increased by the end of November 2014.

**AND WHEREAS** the tenure of the committee earlier was assumed till June 2013 which had been taken for calculating the ad-hoc payment Rs. 14000/- and later stage worked out as Rs.9000/- to remaining schools . The total amount collected earlier from unaided recognised schools as the first ad-hoc payment has been utilised completely.

**NOW** , On account of increase of tenure of JADSC till November 2014 the ad-hoc share payment has been recalculated as Rs. 20000/- ( Rupees Twenty thousand only) including earlier share made. Fresh requirement for ad-hoc share payment from all unaided recognised schools will be as follows:

1. Schools that have already paid Rs. 14000/- to pay Rs. 6000/- more.
2. Schools that have already paid Rs. 9000/- to pay Rs. 11000/- more.
3. Schools that have not paid any amount till date to pay Rs.20000/-.

4. Category D schools identified by the JADSC in its five interim reports available at Home page of department website [www.edudel.nic.in](http://www.edudel.nic.in). that got recognition after the issuance of order dated 11/02/2009 to be exempted from payment.

**THEREFORE** all Mangers / Head of Schools of unaided and recognised schools are directed to pay the revised ad-hoc payment at the following rates through a Pay order/Draft in favour of Account Officer(Cash) Directorate of Education , HQ

- I. Rs. 6000 from the schools that have made contribution Rs. 14000/- earlier
- II. Rs. 11000/- from the schools that have made contribution Rs. 9000/-
- III. Rs. 20000/- from the schools that have not make any contribution so far
- IV. No contribution from the schools that were identified by the JADSC in its five interim reports as category "D" schools available at Home page of department website [www.edudel.nic.in](http://www.edudel.nic.in). that got recognition after the issuance of order dated 11/02/2009 .

All schools will submit duly signed hard copy of the report with the requisite Pay order/Draft in favour of Account Officer (Cash) Directorate of Education (HQ) to the Zonal Office concerned **within a week time from the date of issue of this letter**. It is the duty of all the Managers /Head of Schools of unaided and recognised schools to verify from their bank statements that the earlier payment made as the ad-hoc share to Directorate of Education has been debited from their bank a/c. If not, then they must pay full contribution i.e. Rs.20000/- .

This link also is available at Zonal and District level . Education Officer are required to check thoroughly the Pay order / Bank Drafts received from the schools whether they have been prepared exactly as per the directions of DOE or not. Education officers will submit all the Bank Draft /Pay order along with compiled report in respect of their zone duly signed by the Education officer and DDE **within 15 days from the date of issue of this order to AO (Cash) Head Quarter directly**. Hard copy of the same also is to be submitted to ADE (Act-I)/ DEO (Act-I).
