## PUBLIC CIRCULAR

Sub:- Engagement of Guest Teachers during 2014-15-second list (modified) for verification of documentation.

The second list (modified) of School/Post/Category wise allocation of Guest Teacher applicants can now be down loaded from web portal of the Directorate. Candidates whose name is appearing in this list are directed to approach the HOS of the school immediately for verification of their certificates in support of age, Educational qualifications, Category etc., Allocation of school against the candidate is provisional, subject to the condition that his/her candidature is found in order by the HOSs during the verification of certificates. The last date for verification of certificates at the allocated school is 19.9.2014. If the candidates do not get their certificates verified by 19.9.2014, their candidature shall be treated as cancelled.

Candidates who have already joined as Guest Teachers on the basis of circular dated 8.9.2014 are advised to take formal relieving manually from the HOS concerned and report to the HOS of the school allocated in the modified list.
