The Directorate of Education, Government of National Capital of Territory, Delhi invites applications for appointment to one post of Director (State Council of Education Research & Training) (Group-A Post) in the Pay Band of Rs. 37400-67000+Grade Pay Rs. 10000/- on deputation basis initially for a period of two years. The deputation period is extendable on year to year basis with the consent of borrowing and parent Departments as per the rules and regulation on the subject. The application should also accompany the service particulars of the candidate in the prescribed format as per Annexure-I duly signed by the applicant. The last date of the receipt of the application to the post is **15-12-2014**.

1. Essential qualification:

- i) Master's Degree in a school subject from a recognised university or equivalent.
- ii) Ph.D or equivalent work in educational research with published papers of high standard.

Desirable:

- i) Degree/Diploma in education from a Recognised University/Institution or equivalent.
- ii) Specialisation in any field of Education.

2. Experience :

- i) 15 years experience of teaching in school and /or Teaching Education Institution.
- ii) 10 years experience of Educational Admn. in school and /or Teaching Education Institution.

3. Age Limit:

Maximum 50 years as on 01-01-2014 (Relaxable at the discretion of Competent Authority).

Eligible candidates who fulfill the requisite educational qualifications, experience etc. and who can get themselves relieved immediately by the organization in which they are currently serving may forward their applications through proper channel only clearly mentioning therein teaching and educational administration experience separately alongwith following documents:

1. Attested copies of all certificates of Educational Qualifications, Date of Birth, etc.
2. Experience certificate should be countersigned by the Competent Authority.
3. ACRs Dossier of last 5 years in a sealed cover.
4. Vigilance clearance report, work & conduct and integrity certificate and No Penalty Certificate.

At the time of interview the candidates will be required to produce the No objection from his/her employer to the effect that if selected to the post, he/she shall be relieved from his/her department immediately.

Applications, complete in all respects in the prescribed format should be sent to the Office of the Superintendent, Secretariat Branch, Room No.223, Directorate of Education, Old Sectt, Delhi-54 by **15-12-2014**.
