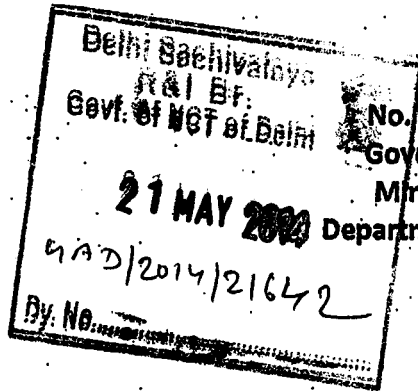



The undersigned is directed to refer to this Department's O.M. of even No. dated 2<sup>nd</sup> May, 2013 revising the Dearness Allowance in respect of employees of Central Government and Central Autonomous Bodies who continue to draw their pay and allowances in the pre-revised scales of pay as per 5<sup>th</sup> Central Pay Commission.

2. The rates of Dearness Allowance admissible to the above categories of employees of Central Government and Central Autonomous bodies shall be enhanced from the existing rate of 166% to 183% w.e.f. 1.7.2013. All other conditions as laid down in the O.M. of even number dated 3<sup>rd</sup> October, 2008 will continue to apply.

3. The contents of this Office Memorandum may also be brought to the notice of the organizations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.

6. The Hindi version of this O.M. is also issued.









The undersigned is directed to refer to this Department's O.M. of even No. dated 16.10.2012 revising the Dearness Allowance w.e.f. 1.7.2012 in respect of employees of Central Government and Central Autonomous Bodies who continue to draw their pay and allowances in the pre-revised scales of pay of 5<sup>th</sup> Central Pay Commission.

The rates of Dearness Allowance admissible to the above categories of employees of Central Government and Central Autonomous Bodies shall be enhanced from the existing rate of 15% to 16% w.e.f. 1.10.2012. All other conditions as laid down in the O.M. of even number dated 3<sup>rd</sup> October, 2008 will continue to apply.

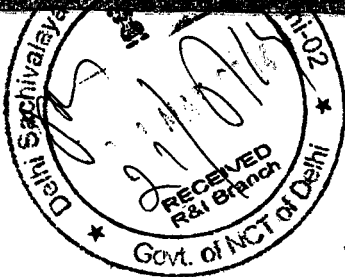
