It is therefore, advised that contents of above mentioned OMs may please be followed strictly while making payment of DA on Conveyance Allowance to the Medical Officers /Central health Service (CHS). OFFICE MEMORANDUM

Subject:

Recommendation of 6th Central Pay Commission- Grant of Conveyance Allowance at the revised rates to Central Health Service (CHS) working in Hospitals/Dispensaries under Central Government-regarding.

The undersigned is directed to say that the recommendation of 6th Central Pay Commission regarding revision of rates of Conveyance Allowance admissible to Central Health Service (CHS) doctors working in Hospitals/Dispensaries under Central Government have been under consideration of the Government of India.

2. The President is pleased to decide that the amount of Conveyance Allowance per month admissible to Central Health Service (CHS) doctors working in Hospitals/Dispensaries for visiting Hospitals or for paying domiciliary visits outside duty hours and performing other official duties, will be revised as indicated below:

- 4. Similarly, conveyance allowance will be paid to CHS doctors working in CGHS dispensaries for paying domiciliary visits and performing other official duties.
- 5. The amount of the Conveyance Allowance will be revised every year equal to the change in the percentage of Dearness Allowance payable for the year vis-à-vis the immediate preceding year.
- For entitlement to the maximum amount of conveyance Allowance 6. mentioned above in Sub-para (2), every Specialist/General Duty Medical Officer is required to pay on an average (to be computed for a three month period) a minimum of 20 visits in a month to the hospital or 20 domiciliary Where however, the number of visits, outside his normal duty hours. domiciliary visits or visits to hospital fall short of this minimum limit of 20 but not below 6, there should be a proportionate reduction in the Conveyance Allowance, subject to minimum grant of conveyance allowance of Rs. 160/-Rs. 80/- and Rs. 60/- p.m. in the case of Specialist/Medical Officers referred to in Sub-para. 2 (I), (II), and (III) above respectively. In case of number of domiciliary visits or visits to the hospital falling below six in number, no conveyance allowance will be admissible. The limit fixed for the minimum number of 20 visits will not however detract a Specialist/Medical Officer from their responsibility towards the patients to render visit to the hospital or paying domiciliary visits if the situation so warrants.
- 7. Every Specialist/Medical Officer claiming conveyance allowance will have to furnish a certificate alongwith monthly pay bill to the effect that he is drawing conveyance allowance in fulfillment of condition No. 6 above.
- 8. No conveyance allowance will be admissible during joining time, leave and any period of temporary transfer.
- 9. Medical Officers/Specialists who draw conveyance allowance at the minimum rate specified in Para. 2 above and those who do not maintain a Motor Car or Motor Cycle/Scooter and draw conveyance allowance @ Rs. 800/-p.m. or Rs. 60/- p.m. as the case may be, will be required to furnish a certificate along with the monthly pay bill, to the effect that the expenditure incurred by them by way of transport/conveyance hire in connection with domiciliary visits/official duty was not less than the amount claimed by them as conveyance allowance.
- 10. Specialists/Medical Officer in receipt of conveyance allowance will not be entitled to draw any daily allowance or mileage allowance for Journeys on official duty, whether, within or beyond a radius of eight kilometers within the city municipal limits.

- 11. In case the conveyance is not maintained or is not available for use, owing to its being out of order or is not used for official journeys/hospital visit for any other reason, for a period of more than 15 days at a time, conveyance allowance will be admissible during such period at the rate prescribed in (1)(iii) above.
- In the case of Medical Officers/Specialists posted to Hospital Departments In the Dr. Ram Manohar Lohia and Safdarjang Hospitals under the CGHS, conveyance allowance in terms of this order will be admissible to those medical officers/specialists who have been allotted a number of CGHS dispensaries and are also available for consultation at the residence of the medical dispensaries. those officers/specialists posted to the aforesald hospitals under the CGHS who are attached to normally not expected to visit dispensaries but occasionally pay domiciliary visits in their zone will be granted conveyance allowance on the basis of log book maintained by them in terms of the Ministry of Finance general orders contained in their O.M. No. F.11(5)-E.IV(B)/60 dated the 24th May 1961 as amended from time to time.
- 13. This order will take effect from 01.09.2008.
- 14. The expenditure involved will be met from the source from which the pay of the Specialists/Medical Officers are drawn.
- 15. These orders are issued in supersession of all the earlier orders on the subject.
- 16. This issues with the concurrence of Department of Expenditure vide their U.O. No F.No. 19039/3/98-E.Iv(Pt) dated 20.4.2009.

OFFICE MEMORANDUM

Subject: Recommendation of 6th Central Pay Commission- Grant of Conveyance Allowance at the revised rates to Central Health Service (CHS) working in Hospitals/Dispensaries under Central Government-Clarifications regarding.

In continuation of this Ministry's O.M. of even number dated 28th April, 2009 on the subject noted above, the undersigned is directed to say that clarifications have been sought by different participating units of CHS on various points of the above O.M. The issues raised have been considered and the clarifications are furnished:

Para. No.5: The rate of conveyance allowance has to be enhanced in proportion to the DA accrued from 1.9.2008 to 31.8.2009, An illustration is given below:

Conveyance Allowance as on 1.9.2008-	Rs.3300
DA increased upto 31.8.2009-	11%
Enhancement in conveyance allowance-	Rs. 363
Revised rate of conveyance allowance-	Rs. 3663

Para. No. 62) The computation of three month period will be calculated from 1.9.2008.

- (ii) The minimum limit of rate of conveyance allowance for minimum 6 visits was mentioned in the order as per recommendations of 6th CPC which also includes the rate of Conveyance allowance for Non-CHS officers which were less than the CHS officers. In case of CHS officers this minimum limit of amount mentioned in the order has no relevance since minimum amount for minimum 6 visits for CHS officers would be higher than the limit fixed by 6th CPC. Therefore the condition fixing minimum amount for minimum 6 visits is obliterated.
- (iii) The CHS doctors cannot limit their visits to 20 for the fact that he has become entitled for maximum amount. He has to make more visits than 20 for the same maximum amount of conveyance allowance if situation warrants.

Para. No.11: The phrase 1 (iii) in this para may be read as 2 (iii). It is also clarified that in case of non-functioning of vehicle, the Officer will be paid as per rate entitlement of those officers who do not maintain any vehicle subject to production of receipt for hiring of vehicle.
