**CIRCULAR**

**Sub:- Implementation of provisions of The Delhi Geo Spatial Data Infrastructure (Management, control, Administration, Security and Safety) Act, 2011.**

Please refer to this Department Circular of even number dated 8.5.2013 on the above cited subject.

The Delhi Geo Spatial Data Infrastructure (Management, control, Administration, Security and Safety) Act, 2011 was notified on 20.4.2011. All line departments/local bodies/public authorities/public and private agencies are required to implement the provisions of the Act, some of which are mentioned below.

2. Section 3 of the "The Delhi Geo Spatial Data Infrastructure (Management, control, Administration, Security and Safety) Act, 2011" reads as under:-

*Every line department, local body, public authority, public and private agency shall:-*

- (a) ensure that various geo-spatial data attributes pertain to them are uploaded in the geo-spatial data base;*
- (b) utilize the geo-spatial data and geo-spatial map for proper coordinated planning, management and delivery of the various services rendered as a part of their administrative and statutory functions;*
- (c) update their respective attribute data continuously on real time basis for updation of geo-spatial data and geo-spatial*



*map created, maintained and managed in accordance with the provisions of this Act;*

(d) *link their respective attribute data to the geo-spatial data and geo-spatial map created, maintained and managed in accordance with the provisions of this Act;*

(e) *ensure safety and security of geo-spatial data.*

3. Section 9(3) and 9(4) of the above mentioned Act read as under:-

Section 9 (3)

*Every line department, local body, public authority, public and private agency shall update the attribute data on real time regular basis. In case of failure, the Regulatory Authority shall be entitled to take action against defaulting officials and/or line department, local body, public authority, public and private agency in the manner provided in the regulations.*

Section 9(4)

*Every line department, local body, public authority, public and private agency rendering services of public utility shall mandatorily use geo-spatial data, geo-spatial map, geo-spatial application, geo-spatial system, geo-spatial portal.*

4. It is hoped that the services of nodal officers of GSDL are being utilized for necessary action.


5. The Regulatory Authority constituted vide order dated 22.8.2013 is empowered under section 16 to enforce the provisions of the Act. However, some departments are yet to fully update their geo-spatial & attribute data. The Regulatory Authority had discussed this issue in the last meeting.



6. Section 10(4) of the above mentioned Act reads as under:-

*It shall be the duty of all the line departments, local bodies, public authorities and public and private agencies, having right to access to the geo-spatial data and the like under this Act to certify in writing every quarter of the year to the Regulatory Authority that all geo-spatial data and attribute data generated as a result of developmental activities has been updated to that effect.*

7. It is requested that quarterly certification under Section 10(4) of the Act be sent for submission before the Regulatory Authority in the format enclosed.
