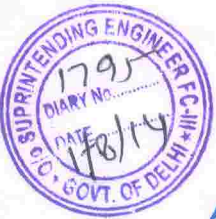

Sir,

The Delhi Transport Infrastructure Development Ltd (DTIDC) is an enterprise of Govt. of NCT of Delhi duly registered as company under the Companies Act, 1956. The main object of formation of this company is to provide autonomy in operations, planning, finance and control in Integrated Transport Infrastructure Development in NCT of Delhi and to provide integrated transport facilities at international standards. Presently it is looking after the work of construction and maintenance of all the ISBTs in Delhi, Transport Authorities, BQS etc. The various precious Transport Infrastructure projects of the company are in planning stage. Due to sudden repatriation of sole Executive Engineer of this office to this parent department, the work of engineering wing is affected badly. However, this office has already invited applications from the employees of various organisation and also selected few of them. It is expected that new incumbents/ deputationists may join this office within a couple of weeks.

Further, it is submitted that the Department of Irrigation and Flood Control, Govt. of NCT of Delhi is situated in ISBT complex. It will be convenient to this office if the Engineers of Department of Irrigation and Flood Control may also look after the works of this office for the intervening period.

It is, therefore, requested that one Executive Engineer (Civil), one Executive Engineer (Elect) and one Superintending Engineer (Civil) of Department of Irrigation & Flood Control, Govt. of NCT of Delhi may be assigned the additional charge of the work of this office atleast for a period of five to six weeks or till their alternate arrangement is made, whichever is earlier.
