## CIRCULAR

Subject: Furnishing of requirement/proposal of Budget under Plan & Non-Plan Schemes/Grant-in-Aid for the Revised Estimates 2014-15 and Budget Estimates 2015-16.

With reference to this office circulars of even numbers dated 20/21.08.2014 and its reminder dated 28.08.2014 & 15.09.2014 on the above subject, it is again mentioned that the reply from your office is still awaited even after lapse of considerable time. Further, the details of revenue receipts in the prescribed format (Statement-X) is still awaited from the Offices of JLC/DLCs of all the nine districts of Labour Department. As a new progress, the Finance Department, GNCTD has revised the proforma of Statement-X and therefore, all JLCs/DLCs of all the nine districts alongwith the Offices of Chief Inspector of Factories and Boilers & Dy. Electrical Inspector are required to furnish the information regarding revenue receipts in the enclosed format.

It is requested to furnish the requisite information/report in respect of R.E. 2014-15 and B.E. 2015-16 (with reasons for variation in the amount), so that the consolidated requirement/proposal could be formulated and demanded from Finance Department, GNCTD. The demand of Grant-in-Aid should be submitted with specific bifurcation into 03 categories and the demand of SCSP & CSS Schemes be also submitted. Kindly arrenge to furnish the requisite information in the Accounts Branch <u>by</u> 25.09.2014 positively.

It may be noted that if no information/report is received by 25.09.2014, it will be presumed that no change is required in the Revised Estimates 2014-15 and the same figure will be treated as final for Budget Estimates 2015-16 also and no further addition/deletion will be entertained on the requests received after 25.09.2014. Any lapse in the matter will rest with the Officer concerned due to non-furnishing of the requisite information/report.
