CIRCULAR

The Housing Allotment Committee in its last meeting observed that the 'Priority Lists', for change as well as fresh allotments of Government Accommodation under DTTE pool, maintained in the Allotment Branch, in respect of the applicants to whom recommendations for allotment could not be made due to non-availability of quarter in their desired campus/floor/category are very old and these 'Priority Lists' are carried forward meeting after meeting of the HAC, resulting in to accumulation of applications. Many a time, when the allotment of Govt. accommodation is made on the basis of these applications, the applicants refuse to accept the allotment, for the reasons best known to them. Similarly, many applicants who got allotment from other Pools, do not inform this office and their applications are being considered and placed before the HAC repeatedly. These have often resulted in to a situation, wherein the genuine applicants, who actually require an accommodation, could not get any chance.

The Housing Allotment Committee has thus recommended that the 'Priority lists' for change as well as fresh allotments of Govt. quarters under DTTE Pool, maintained in the Allotment Branch, whose cases could not be recommended for allotment due to various reasons, should be cancelled forthwith and fresh applications for change as well as fresh allotments of Govt. accommodations under DTTE Pool may be invited. These applications will be invited after every HAC meeting. The application received for a particular HAC meeting will not be considered for the next HAC meeting.

In pursuance of the above recommendations, the Competent Authority has approved the cancellation of the 'Priority lists' for change as well as fresh allotments of Govt. quarters for Type-I to V categories maintained in the Allotment Branch as on 26-05-2015.

Head of all Polytechnics/ITIs and Branch Incharges, DTTE (HQ)/BTE are requested to bring the contents of this circular to the officials working under their control and forward the applications for allotment of Govt. accommodations under DTTE Pool in respect of the desired officials, if any, to this office for consideration.
