OFFICE MEMORANDUM

Subject: Relaxation of economy ban in respect of purchase of furniture required for the use of Class Room / Laboratories / Libraries / Hostels / Homes of the departments of Government of NCT of Delhi.

The competent authority is pleased to delete the condition of 'relaxation from FD on account of economy ban' in respect of purchase of new furniture as well as purchase of furniture against condemnation required for the use of Class Rooms / Laboratories / Libraries / Hostels / Homes of the departments of Government of NCT of Delhi with following conditions:-

- (a) This power will be exercised only by the Administrative Secretary of the department concerned;
- (b) No additional funds will be provided for this purpose;
- (c) The department will ensure the financial prudence and the procurement will be made in transparent, competitive and fair manner as prescribed in GFR, 2005, to secure best value for money;
- (d) In case the purchases are made through PWD, any agency such DSIIDC, etc., the administrative Secretary should ensure that these agencies follow the due procedure prescribed in GFR, 2005;
- (e) The department should also certify the reasonability of the cost of the furniture to be procured; and
- (f) The departments will continue to seek the relaxation of economy ban from FD in respect of purchases of office furniture.


