You are aware that Govt. of India has launched "Swachh Bharat Mission" on 2<sup>nd</sup> October, 2014 to achieve complete cleanliness in the country by 2<sup>nd</sup> October, 2019. Hon'ble Prime Minister has called upon all concerned, at various forums, to contribute intensively for creation of public awareness about cleanliness and its advantages. The Mission covers all 4,041 statutory cities and towns as per census 2011 and the components eligible under SBM with broad funding pattern are (i) Household Toilet - Rs.4,000 per toilet as an incentive; (ii) Community Toilet – max. 40% VGF; (iii) Public toilets - 100% private investment; and (iv) Solid Waste Management Project – max. 20% VGF. - 3. May I, therefore, request you to "commit yourself totally" to ensure cleanliness in the entire town/city especially around the places of concern and call upon citizens also to commit themselves totally to cleanliness. This may be started as a Swachhta drive w.e.f. 25th December, 2014. They should also be encouraged to take appropriate measures like awareness creation, maintaining cleanliness in and around residential/ work/ business/institutional premises, displaying of SBM logo and administering Swachhta Pledge etc. You are further requested to ensure that Ward Councillors take up the exercise in right earnestness and they motivate citizens also to voluntarily dedicate at least two hours per week of service towards cleanliness and upload the photographs of the places before and after the cleanliness drive to the website www.mygov.in regularly every week.
