Proposed actions/programmes during Vigilance Awareness Week- 2015
(26/10/2015 to 31/10/2015)

- Taking pledge on 26/10/2015 at 11:00 AM under the guidance of HODs in the departments outside Delhi Secretariat. At Delhi Secretariat, the pledge may be taken by the staff and officers under the guidance of Chief Secretary in Plaza area.

Action: All HODs and Pr. Secretary (GAD).

- Display of banners, posters etc. at prime locations in offices and places with public interface.

Action: All HODs and Pr. Secretary (GAD).

- Carrying out media campaign on anti-corruption. Directorate of Vigilance may publish advertisements in the leading local news papers, mentioning the address & telephone numbers at which the public may provide information/inputs regarding corrupt practices in Government offices.

Action: All HODs and Secretary (Vig.)/DOV.

- Organizing debates/lectures/essay writing competitions on moral values, ethics, good governance practices etc. amongst the employees. "

Action: AR department.

- Organizing workshops on moral values, ethics, good governance practices, simplification of procedures, transparency etc. in big public dealing departments/organizations, such as Municipal Corporations, Education department, Trade & Taxes department, Transport department, Health & Family Welfare department, Food & Supplies department, Revenue department etc. In some departments/organizations, the Chief Secretary/CVO, Pr. Secretary (Vigilance) and Secretary (Vigilance) may also participate in the workshop.

Action: All departments/Autonomous Bodies.

- Organizing training programme for the staff & officers working in Vigilance wings of various departments/organizations, in two sessions, on 31/10/2015 by the Department of Training/UTCS to update their knowledge on vigilance matters.

Action: Director (Training)/UTCS.
