CIRCULAR

Subject: Re-structuring of Vehicle Drivers cadre

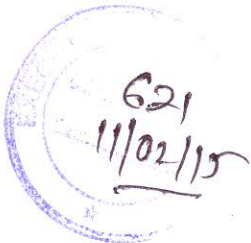
At present, in Delhi Jal Board, there are four categories of Vehicle Drivers, mentioned as under:

- (i) Vehicle Driver (Ordinary Grade) {Pay Band Rs. 5200 – 20200 with Grade Pay Rs. 1900/-}
- (ii) Vehicle Driver (Grade-II) {Pay Band Rs. 5200 – 20200 with Grade Pay Rs. 2400/-}
- (iii) Vehicle Driver (Grade-I) {Pay Band Rs. 5200 – 20200 with Grade Pay Rs. 2800/-}
- (iv) Vehicle Driver (Special Grade) {Pay Band Rs. 9300 – 34800 with Grade Pay Rs. 4200/-}

Prior to above, in Delhi Jal Board there was only one category of Driver known by the post 'Vehicle Driver' in the pay scale of Rs. 4000-6000.

Now, Delhi Jal Board vide Resolution No. 145, Item No. Admn. 37 has approved to place the present structure of vehicle drivers to its original structure, which was in existence prior to present one with the following clauses:

- a. The existing nomenclature of vehicle drivers i.e. Vehicle Driver (Ord. Grade), Vehicle Driver (Grade-II), Vehicle Driver (Grade-I) & Vehicle Driver (Spl. Grade) in DJB be changed to Vehicle Driver with the identification of their Pay Band and Grade Pay.
- b. The initial/entry pay scale of vehicle drivers be changed to Pay Band: 5200-20200 in the Grade Pay of Rs. 2400/-.
- c. The existing pay scales of all the vehicle drivers (who are getting grade pay less than 2400) be revised to grade pay of Rs. 2400 from the date of issuance of this circular. This revision will not be considered as up-gradation in MACP.

- d. After re-structuring of vehicle drivers, there will be no further promotion of vehicle drivers considering them as ex-cadre post. Only MACP benefits be granted.
- e. Financial up-gradation under ACPs /MACPs/Promotion (already given before implementation of this structure) be not changed/revised. These will be counted in the total 03 up-gradations to be given to Govt. employees.
- f. If any vehicle driver, who has got three (03) number of up-gradation in his entire services either in the form of ACP/MACP/Promotion (before implementation of this structure) will not be considered as eligible for any more up-gradation in any form.
- g. In the present re-structuring of vehicle drivers, only subsequent due MACP/ACP will be given as per the new structure on the basis of past service performed by him.

All the DDOs/officers are requested to take action in accordance to above mentioned Board approval. And, henceforth the MACP/ACP proformas in respect of all the vehicle drivers may be sent according to above approval.
