Three posts of Chief Engineer (E&M) in Delhi Jal Board, Government of National Capita Territory of Delhi in PB-4 of ₹ 37400-67000+ GP -₹ 10000/- plus other usual allowances as admissible under the rules are required to be filled in on deputation basis including short term contract amongst Officers under the Central/State Govts./UTs/ Recognized Research Institutions/Public Sector Undertakings/ Sem Government/Statutory or Autonomous Organization from the eligible officers:
(a) (i) Holding analogous post on regular basis.
OR
(ii) With 8 year's regular service in the post in the scale of Rs. 12000-16500 (Pre-revised) OR equivalent and
(a) Possessing the following educational qualification and experience:-
(i) Degree in Electrical/Mechanical Engineering from a recognized University or equivalent;

15 years of experience of operation and maintenance of large water and sewage treatment plant and of planning. Designing and electring of the plants including laying of water, drainage and sewage works etc.

( The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for

consideration for appointment by promotion). (Period of deputation/Contract including period of

deputation /Contract in another Ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment on deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications).

Since, Delhi Jal Board follows the rules/regulations and instructions of Government of NCT of Delhi/Govt. of India, DOP&T OM No. 02.12.87-Establishment/PL-II dated 29.01.1988 as amended from time to time shall be applicable mutatis mutandis to the officer on deputation.

It is therefore requested that if you could forward the Bio-Data duly signed by the candidates and other service particulars of the suitable candidate along with complete and up to date CR Dossier who could be spared in the event of selection may be sent to the undersigned so as to reach latest by 15<sup>th</sup> July-2015.
