PUBLIC CIRCULAR

SUB: Online entry of EWS & DG category students for the academic session 2013-14 & 2014-15 for reimbursement of per child expenditure under the provisions of RTE Act, 2009.

- 1. In continuation of this office circular of even no. dated 14/08/2014 and the subsequent reminder dated 18/11/2014 on the above subject, it is stated that despite repeated reminders only 427 schools(DOE recognized) have submitted their data/claims as against the total no 1700 schools. In case of unaided Pvt. Schools under local bodies, none of the schools have submitted the data. The eligible private unaided schools are entitled for reimbursement of per child expenditure up to a maximum of Rs. 1290/- per month per child or the actual expenditure charged whichever is less in r/o students admitted under EWS & DG category.
- 2. All heads of unaided recognized schools of Delhi (under DOE/MCD's/NDMC/DCB) are again directed to submit the details of students admitted under EWS & DG category during 2013-14 (if not entered earlier) & 2014-15 session in the online module(s) using school login ID and password at link School plant=> EWS for 2013-14 & 2014-15 in the web portal of this Directorate (www.edudel.nic.in) by using Internet Explorer. Information against all items must be filled with due care and no item shall be left blank. Information shall be submitted latest by 15/01/2015. Printout of the online report duly certified by HOS shall be submitted by 20/01/2015 to the E.O (zone) concerned.
- 3. It is further informed that claims relating to previous years namely 2011-12 & 2012-13, if any, shall be submitted in the excel worksheet in the same format by sending an e-mail to concerned E.O.(zone) along with the hard copy.



- 4. Education Officer concerned are directed to forward the online data (including data sent on e-mail for previous years) submitted by private unaided schools of DOE for further processing after verification. Hard copies submitted by schools shall be retained at distt./zone only. Similarly, claims of 2011-12 &2012-13 received through e-mail may be consolidated at the district level. The demand for allocation of funds under the scheme be sent to Planning Branch.
- 5. DD(Edu.) / AD(Edu.) at zonal level in MCD's /NDMC/DCB are advised to forward the online data submitted by private un-aided schools under their respective jurisdiction by using the user ID & password issued to respective local bodies. Hard copy will not be entertained in this Directorate.
