CIRCULAR

Sub: Extension of provisional recognition granted upto Primary /Elementary level under RTE Act, 2009 for further period of one year beyond 30-09-2014.

Please refer to this Directorate's Circular No. DE.15(166)/Act-I/Policy/Land Norms/2013/23675-23686 Dated 16-05-2014 vide which the period of provisional recognition granted to Primary/Elementary Schools under the provisions of RTE Act, 2009, Delhi RTE Rules 2011, Notification No. DE/15(206)/Act/2013/7901-7916 dated 25.03.2013 and Circular No.DE/15(206)/Act/2013/7886-7900 dated 22.03.2013 was further extended for a period of six months up to 30-09-2014 for completion of inspections of these schools by the district authorities.

District Authorities were to ensure that these schools must fulfill the terms & conditions of provisional recognition & provisions of Delhi School Education Act & Rules, 1973 & Right of Children for Free & Compulsory Education Act, 2009.

As the said inspection work of all such schools (about 300 cases) have still not been conducted by the district authorities, therefore further decision could not be taken for extension of provisional recognition granted to these schools.

The matter was examined and observed that it is necessary to extend the timeline of the provisional recognitions of the schools granted up to Primary/Elementary level under the provisions of RTE, Act, 09 with a view to safeguard the interest of the children studying in these schools.

Therefore, it has been decided by the Competent Authority to extend the period of provisional recognition for a further period of one year i.e. up to **30-09-2015** to enable the district authorities to carry out inspections of all these schools and ensuring compliance of the terms & conditions of provisional recognition & provisions of Delhi School Education Act & Rules, 1973 & Right of Children for Free & Compulsory Education Act, 2009.

Hence, the period of provisional recognition in r/o those schools to whom provisional recognition was granted for Primary/ Elementary level under RTE Act, 2009 up to 31-03-2014, which was again extended up to 30-09-2014, is now further extended **upto 30-09-2015**.

Further, all DDEs are hereby directed to complete the inspection work latest by **31-05-2015** and further ensure the fulfillment of terms & conditions of provisional recognition & provisions of Delhi School Education Act & Rules, 1973 & Right of Children for Free & Compulsory Education Act, 2009 by these schools and thereafter forward all such cases to this branch for taking further action in the matter. All the DDEs must note that no further extension shall be granted in the matter.

No action will be initiated against unrecognized schools found functioning from academic year 2014-15 onwards i.e. 01-04-2014 under the provisions of RTE Act, 2009 till the said extended period or formulation of further guidelines, if any, whichever is earlier.

This issues with the approval of the Competent Authority.
