The Appellant through his RTI application dated 20.01.2014 had sought to know the details of the Officers who had inspected the report of DAV Public School dated 18.10.2012 i.e their name, designation , Mobile No., sanction taken and all the reports prepared by the department including discrepancy report on the reply dated 17.06.2013 sent by DAVPS to the department, reply received form Deputy CAG on the department request dated 06.12.2013 for auditing of records of DAVPS, etc. . PIO replied on 21.02.2014 giving point-wise reply to the appellant. Being unsatisfied with the information furnished, the appellant preferred First Appeal. FAA by his Order dated 19.03.2014 upheld the information furnished by the PIO. Claiming non-satisfaction with the





On examining the reply of DAV Public School, Sreshtha Vihar, Delhi, the school authority, vide this office letter dated 24.06.2014, was asked to submit the following documents:-

1. To provide a copy of latest Health Certificate.
2. To provide all the relevant records for scrutiny on the basis of fee hike have been made.

In response, the Principal, D,A,V. Public School, Shreshtha Vihar, Delhi-110092 vide letter dated 19.07.2014, has submitted following documents:-

1. Copy of latest Health Certificate dt. 17.07.2013 which is valid for one year.
2. Copy of minutes of the meeting held on 15th March,2011, 23rd March, 2012 & 21st March,2013 in the presence of the LMC members including D.Es Nominees alongwith the attendance sheets of the respective meetings of the basis of which fee hike have been made.

On examining the reply, it has been observed that the school did not the submit the valid Health Certificate.

Perusal of minutes of the meetings of LMC revealed that the fee hike was unanimously approved by the LMC but it is learnt that the matter regarding fee hike is pending before the Hon'ble Justice Anil Dev Committee. Hence we need not to comment in the matter.

Further, we have received a complaint dated 28.07.2014 from Sh. Manish Aggarwal against the Inspection Report copy of which he obtained under the provisions of the RTI Act, 2005 by raising following issues:-

1. The school is appointing staff on contract basis which is illegal.
2. A canteen and Ice cream Vendor is situated on Ground Floor. Also there is a snack bare on the third floor of the school building. There are also running a stationery and uniform shop near canteen.
3. The entire building of school is un-regularized. Also the building has been booked by MCD for demolition. Copy of the demolition order enclosed.
4. The school is running nursery branch illegally encroached land for which the DDA has passed the demolition orders.

He has requested to appoint any other high rank trust worthy office to audit the Inspection Report and issue a new letter of deficiencies to DAV Public School, Sreshtha Vihar.

In this connection, it is submitted that among the other issues, the issue raised by Sh. Manish Aggarwal are being examined by this office in the main file of DAV Public School, Sreshtha Vihar and appropriate action may be taken. Hence, there appears no need to re-examine the Inspection Report

In view of above, if approved, we may file the inspection report of DAV Public School, Sreshtha Vihar with advice to obtain the Latest Health Certificate and the Complainant Sh. Manish Aggarwal may also be informed accordingly.
