CIRCULAR

Right of Children to Free and Compulsory Education Act, 2009 makes it mandatory for all Private Unaided Recognized Schools to admit at least 25% children belonging to Economically Weaker Sections and Disadvantaged Group Category to Entry Level Classes and provide free and compulsory education to them till completion of elementary education. Further, the Private Unaided Recognized Schools (Non-Minority) running on the land allotted by the Govt. Agencies are also under obligation to admit 20% children belonging to EWS Category in all fresh admissions in upper classes.

The Income and Caste certificates issued by the competent authority of Revenue Department, GNCT of Delhi are fundamental and decisive documents to claim the benefits under EWS/DG Category.

One of the District Magistrates of Revenue Department, GNCT of Delhi has brought to the notice of this Directorate that a few admissions under EWS category in various schools of Delhi have been got done on the basis of forged and fake Income Certificates submitted by the respective parents. It has also been informed that due deligence is not being exercised and verification of Income Certificates and Caste Certificates is not being done by the Principals/Managements of the schools at the time of admission. As a result, ineligible people are getting undue benefits and eligible/deserving students are deprived of admission under the above said categories.

Further, it has been informed by the said District Magistrate that various Govt. Certificates including income/caste certificates etc. issued by the Revenue Department be verified by the school authorities online **at www. esla.delhi.gov.in >Revenue Department** or in paper form from the office of the respective District Magistrates of Revenue Department before extending any benefits to the applicants on the basis of the certificates produced.

The Directorate has taken the said irregularities in admissions of EWS/DG Category students seriously.

Therefore, all the Principals/Managements of Private Unaided Recognized Schools of Delhi are hereby directed to be cautious in this regard and exercise due diligence as well as carry out necessary verification before admissions so as to ensure that benefits of admission under EWS/DG Category students reach the eligible and deserving students.

Further, all Dy. Directors of Education are also advised to ensure that the above said instructions are adhered strictly by all the unaided private recognized schools.

This issues with the prior approval of the Competent Authority.

CIRCULAR

It has come to the notice of the undersigned that a number of admissions under EWS category are done in various schools of Delhi including District North-West on the basis of forged and fake income Certificates produced by the respective parents. An investigation is also being carried out by Special Cell of Delhi Police in few of the cases regarding such illegalities. It is observed that the due diligence/verification of these EWS certificates is not done by the respective Principals/Management of the Schools at the time of admissions. As a result, unscrupulous elements are getting undue benefit whereas eligible deserving and poor students are deprived of admissions under EWS quota besides other facilities which such unscrupulous elements claim on account of such forged/fake Caste and Income certificates etc.

To discourage and expose such practices, it is informed that various Govt. Certificates including income certificates/caste certificates etc. issued by this office be verified by the school authorities online at www.esla.delhi.gov.in > Revenue Department or in paper form through this office before extending any benefits to the applicants on the basis of the certificates produced. If any further clarification/verification is required, copy of certificates may be forwarded to this office for verification of the same or the Nodal Oficer of your school may contact this office.

The above instructions may be adhered to strictly to ensure that benefits, Government schemes are extended only to eligible persons.
