Scheme for Regularisation of Guest Teacher of Directorate of Education during session 2015-16.

Education is the foundation of any society. It lays the groundwork for the future direction of people's lives and the societies they live in. It is a fundamental human right and essential for the exercise of all other human rights and also for social, political, and economic participation.

If those imparting education are themselves facing uncertainties in terms of salary and permanency of job, then this would have a bearing on the quality of education. This government is committed to providing quality education and is also sympathetic towards the demands of guest teachers. Therefore, the government has proposed a draft scheme for regularization of guest teachers.

Please find enclosed herewith the draft scheme for Regularization of Guest Teachers of Directorate of Education 2015-16 brought out as a onetime measure. The scheme has been devised in accordance with the commitment of the government to regularize the services of guest teachers, without compromising on the quality aspect of the teachers.

All those interested candidates, who worked as Guest Teacher/Contract Teacher (Sarva Shiksha Abhiyan) in the schools under the Directorate of Education, are advised to go through the contents of the scheme thoroughly and offer their comments/suggestions in writing either in person or through email (planning.branch@yahoo.com) for examination. The last date for submission of comments/suggestions is 15.06.2015.

Salient Features of "Scheme of regularization of Guest Teachers in the Directorate of Education – 2015-16" (Proposed)

- The present scheme is called "Scheme for regularization of Guest Teachers in the Directorate of Education – 2015-16".
- 2. The "Scheme for regularization of Guest Teachers in the Directorate of Education 2015-16", covers all those candidates who have worked as Guest Teacher(s) during 2014-15 irrespective of number days engaged and while in respect of candidates of 2012-13 and 2013-14 they must have worked for not less than 90 days in any one year out of the two years.
- Contract teachers of Sarva Shiksha Abhiyan (S.S.A). fulfilling the above criteria will also be covered under this scheme.
- 4. The tentative list of Guest Teacher applicants eligible for Recruitment Test to be conducted by DSSSB will be prepared by Directorate of Education (DOE). This list will be displayed on the web-portal of DOE to obtain latest address for communication, email, and mobile numbers etc to update the data of applicants and also invite objections / grievances, if any for non-inclusion from the applicants before finalizing the same. This list will be supplied to DSSSB for organizing the Recruitment Test.
- 5. The candidates shall possess the requisite essential qualifications prescribed for the post for which he or she will be considered as per RRs notified by the Directorate. Age relaxation as may be needed over and above the maximum age prescribed for the said post as per RRs will be given with the approval of the competent authority as a onetime measure.
- 6. All the eligible candidates under the proposed scheme of regularization will be required to appear for a written test to be conducted exclusively for them by DSSSB to finalize the select list. DSSSB will collect the requisite Test fee from the applicants as per their norms. The details of exam schedule, number of posts subject and category wise taken up for regularization under this scheme will be displayed in the DSSSB web-portal. Each applicant will be allowed to appear for the Recruitment Test in respect of any one post of his/her choice if the said applicant was engaged for different posts during the last three years namely, 2012-13, 2013-14 and 2014-15.

For this purpose DSSSB will direct the shortlisted candidates for the special recruitment test to fill the requisite application form as prescribed by the DSSSB *on line* for entering qualification, Date of Birth ,Choice of Post for which applying, upload photograph and signature etc., so that these candidates can be assigned Roll Nos. and examination centre by DSSSB.

- 7. In respect of Asstt. Teacher Primary and TGTs posts essential qualification as per RRs requires passing of CTET. The candidates with CTET and qualified in the DSSSB Recruitment Test will be considered for appointment as a regular teacher immediately after due verification of original certificates in support of age, educational qualification, caste certificates etc. However, candidates without CTET, but qualified in the DSSSB recruitment test will be given one year period of time to pass CTET exam, to be considered for regularization. The one year period shall be counted from the date of publication of DSSSB Recruitment Test Result. Candidates who fail to pass CTET exam within the stipulated time period shall forfeit their right for regularization under this scheme and no extension of time shall be given in this regard.
- 8. In case of Assistant Teachers (Nursery & Primary), Lecturer (PGTs) posts of Economics, Engineering Drawing & Maths, TGT Home Science, TGT Bengali, Spl. Education Teachers (SETs) and Educational and Vocational Guidance Counsellors (EVGCs), no new posts have been created, though candidates are available for regularisation. Candidates applying for these posts are informed thatin respect of these posts, it is proposed that vacancies that remain unfilled after the ongoing DSSSB selection process, if any, will be diverted to the proposed scheme in the interest of the candidates. However, the number of such un-filled vacancies can be known only after the conclusion of the ongoing recruitment process by DSSSB. Therefore, all those candidates qualified in the proposed Recruitment Test for such categories of posts and waiting for regularisation under the scheme will be kept in a panel for a period of one year with the approval of Competent Authority. If no vacancy is available for regularisation the panel will automatically lapse and the candidates will have no claim whatsoever in this regard.
- Reservation to SC/ST/OBC (Delhi Only)/PH will be provided as per Government Rules
- 10. The applicants who fail to clear the DSSSB Recruitment Test will have no claim whatsoever under the proposed scheme.
