CIRCULAR

SUBJECT: INVOLVING VARIOUS ORGANISATIONS IN 'EDUCATION THROUGH EXTRA CURRICULAR ACTIVITIES'.

The main aim of the education is the 'holistic' development of the children. Every single child has potential to excel in one field or the other. From our experience in schools, we know that some of the children who apart from academics, may do very well in other spheres of education. And as educators, it is our duty to locate that latent capacity and provide it with congenial atmosphere and abundance of opportunities to grow to its fullest strength.

This objective of all round growth can be achieved only if the children are given plenty of exposure to areas like music, visual arts, theatre, dance, sports & games etc so that they can explore and realize their innate inclination and abilities. It is a proven fact that once a child is able to discover an area in which he/she feels comfortable and can do well, the self esteem of the child improves dramatically and this can have a charismatic effect on his/her overall personality.

Moreover, engagements like arts/sports teach leadership, team spirit, effective communication and give children the right perspective to see the world around and also endow them with emotional equilibrium.

It is with these and similar ideas that the Directorate of Education has decided to provide quality exposure to its students to various creative arts e.g. Dance, Theatre, Photography, Music, Sports etc. The Directorate is starting a new scheme, as detailed in Annexure-I, vide which different academies/institutions/clubs/professionals who have proven track record, will be involved in imparting training to students in the above non scholastic areas in 54 Pilot Schools, in first phase, as per list attached.

ANNEXURE-1

Scheme for involving various academies/clubs/ Individual professionals into the training of Music, Dance, Theatre, Fine Arts, Creative Writing & Photography activities for the students.

- The Directorate of Education aims for broad basing of Music, Dance, Theatre, Fine Arts, Creative Writing & Photography activities at grass root level by involving various academies/clubs/individual professionals.
- Various academies/clubs/individual professionals will be provided an opportunity to impart training and coaching to the students in the 54 model Government schools of Dte. of Education.
- Under this scheme, Music, Dance (including classical and contemporary), Theatre, Fine Arts (including craft), Creative Writing & Photography will be promoted.
- 4. The Directorate of Education will allow access to the desirous academies/clubs/individual professionals into the schools. They will be provided requisite space in the schools for imparting coaching and training to the students of govt & other schools. Each academy / club / individual professional will be paid Rs. 2,000/- per class (at least for 2 hrs.) per school (at least twice a week) for rendering this service. This payment will be for the main trainer. However, if there is a need for assistant trainer, then he / she will be paid Rs. 1,500/- per class. However, if any academy / club / institution intends to impart training on a complete package basis, then the same may be considered after verifying the credentials of the academy / club / institution.
- The desirous academies/clubs/individual professionals will have to provide training to minimum 50 number of students, per activity, of that school.
- 6. An academy/club/individual professional will have to fulfil any of the following essential conditions for enrolment with the Directorate of Education:

It / she /he should have an experience of, at least, 5 years in the field of training and his/her trainees should have performed at national level. It / she /he should possess the basic technical qualification in the field of training from any recognized institute;

OR

It / she /he should have participated in any Music, Dance, theatre, Fine Arts, Creative Writing or Photography activity at either state/national/international level & should have trained students in this field for at least three years and his / her trainees should have performed at national level.

- 7. The following parameters will be laid down for implementing the scheme:
 - The academies/clubs/individual professionals will have to enroll themselves, school wise, with the Directorate of Education, Govt. of NCT of Delhi.
 - Each academy/club/individual will be allotted schools taking into consideration the credentials and other required parameters.
 - 3. The Head of the School will have liberty to identify any activity or activities and accordingly identify interested students in this field. The number of days of training as well as time duration will be agreed upon mutually by the academy/club/individual professional with the Head of the school. But it will be restricted to 2 classes per week of at least two hours duration.
 - 4. One room or hall will be provided in the school premises for usage. No charges will be levied on the academy/club/individual on account of usage of the school premises.
 - 5. The permission will be accorded upto 29th February 2016, initially. Every Academy/Club/Individual professional will submit their performance report on Quarterly basis. The academies / clubs / individual trainers will make stage presentations (wherever applicable) or photo exhibition of these students, at an appropriate time. For making stage presentations or photo exhibition, the budget will be provided separately to the tune of approx. Rs. 20,000/- to 25,000/-. The performance of each academy/club/individual will be reviewed from time to time and, if necessary, the arrangement will be renewed for another period but not beyond 1 year.

- For music and dance activities, the CD player or Tape recorder, CDs, Audio Tapes etc. will be procured / hired by the Head of the School. For Photography activity, the trainer will bring his / her camera as well as cassette / CD for imparting training.
- 7. In case, non-satisfactory performance is reported at any stage, the permission may be withdrawn.
- Each academy/club/individual professional will ensure safety and security of the players at its own level.
- 9. No subletting, sub-leasing or outsourcing of responsibilities shall be allowed under any circumstances. The academy / club shall have to declare its qualified trainer as well as assistant trainer for a particular school well in advance, before final offer letter is issued by the Directorate.
- 10. Strict discipline will be maintained at the time of training by the Club/Academy/Individual professional.
- 11. One academy/club/individual will be allowed to impart training and coaching in these activities only on "As is Where is" basis. It is preferred that the academies/clubs/ individuals should visit the desired schools, before applying, to take stock of the actual position of the school premises.
- The electricity & water charges, if any, will be borne by the respective school.
- 13. The coaching and training will be imparted, preferably, during school hours or during the time mutually agreed upon before and after school hours as well as on holidays.
- 14. Efforts will be made to allot marks to the students on the basis of their performance in the class as well as final show adding to their total score.
- 15. Overall sanitation will continue to be maintained by the respective school.
- 16. The prescribed proforma, in which the academies/clubs/ individual professionals will submit their proposal as well as the Checklist, is enclosed herewith.
- 17. In case of any dispute or interpretation of the scheme, the decision of the Directorate of Education will be final and binding upon the academy/club/individual professional.
- 18. This Directorate reserves the right to change/alter/withdraw these any of/all terms and conditions.
