**MEETING NOTICE**

With reference to Order No. PS/DE/2015/451 dated 3/12/15 of the Directorate of Education regarding the constitution of Core Committee and Sub Committees for Syllabus Reduction, a full day meeting cum workshop for the **Core team members** is being organised at the SCERT, Varun Marg, New Delhi on Tuesday, 22<sup>nd</sup> December, 2015 from 10 am to 5 pm.

The Agenda of the meeting as stated in the Order is to:

1. Examine the recommendations given by teachers/officers of the Directorate of Education w.r.t, reduction (upto 25%) in syllabi of classes VI to VIII and IX & X.
2. Examine the Feedback/recommendations/suggestions given by teachers of Govt.aided/private schools, especially those submitted by the National Progressive Schools' Conference.
3. Give final recommendations on which portions of syllabi should be deleted so as to bring down the load of curriculum upto 25%. While making these recommendations the committee shall ensure that the deletions recommended by them do not create any knowledge/understanding gaps.
4. Wherever there are chances for such gaps on account of the deletions, the committee shall suggest activities/exercises/summarized contents etc. which can be included in the remaining syllabus so that students face no difficulty in grasping the remaining concepts/units.
5. The Committee may also give recommendations regarding any modifications/additions that may be deemed absolutely essential.

All members of the **Core Committee from S. No. 1 to 24** on the list are requested to attend the one day meeting at the aforesaid date, time and Venue.
