ORDER

Whereas the Lt. Governor of the National Capital Territory of Delhi is of the opinion that it is necessary and expedient to specify a procedure for enabling the identification of stocks of edible oils which are not adulterated and to ensure that edible oils which are ordinarily kept for sale and are not adulterated are not withheld from sale.

Now, therefore, in exercise of the powers conferred by clause (e) of subsection (2) of section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the Government of India, Ministry of Agriculture and Irrigation (Department of Food) Order GSR 800 dated 9, JUNE 1978, the Lt. Governor of the National Capital Territory of Delhi hereby makes the following Order, Namely :-

1. Short Title Extent and Commencement :

- (1) This Order may be called the Delhi Edible Oils (Procedure for Identification and Declaration of Unadulterated stocks) Order, 1998.
- (2) It extends to the whole of the National Capital Territory of Delhi.
- (3) It shall come into force with immediate effect.

2. Definitions :

- (1) In this order unless the context otherwise requires,-
  - (a) "adulterated" shall have the same meaning as in clause (i-a) of section 2 of the Prevention of Food Adulteration Act 1954 (37 of 1954) and the term 'unadulterated' shall be construed accordingly;
  - (b) "clause" means a clause of this Control Order;
  - (c) "Commissioner" means the Commissioner of Food and Civil Supplies, Delhi and includes such other officer as may be authorised by the Lt. Governor to exercise all or any of the powers of the Commissioner under this Order;
  - (d) "competent laboratory" means any laboratory specified in the Schedule-I to this order;
  - (e) "dealer" means a dealer as defined in the Delhi Sales Tax Act, 1975 (43 of 1975), and includes a manufacturer, packer and distributor;
  - (f) "edible oil" includes vanaspati, ghee and butteroil;
  - (g) "Lt. Governor" means the Lt. Governor of the National Capital Territory of Delhi referred under article 239AA of the Constitution;

"Manufacture" shall have the same meaning as is assigned under clause (viii-b) of section 2 of the Prevention of Food Adulteration Act, 1954 (37 of 1954), and the terms "manufacturer" and "packer" shall be construed accordingly;

"sub-clause" means a sub-clause of this Control Order;

"Sub-Divisional Officer" means an officer appointed by the Lt. Governor as the officer in charge of subdivision under the law relating to land revenue.

The Lt. Governor may, by notification in the official Gazette, add to, delete from, or amend Schedule-I specifying the particulars of competent laboratories.

Procedure for identification of stocks of unadulterated edible oils other than mustard oil in the possession of dealers at the commencement of the Order:

To remove any doubt regarding the safety of edible oils ordinarily kept by him for sale, any dealer who has in his possession stocks of any edible oil other than mustard oil, shall ascertain whether the said stock or any part thereof obtained by him from any known source of production or supply is adulterated by drawing a representative sample from the said stock or part thereof and have the sample analysed in any competent laboratory:

Provided that the analysis shall include detection of argemone oil by the Thin Layer Chromatography method.

If on analysis any sample is found to be adulterated, the dealer shall withhold it from sale, and send an intimation to the Sub Divisional Officer of the sub division in which his place of business is situated.

If on analysis referred to in sub clause (1), it is found that the sample is not adulterated, the dealer shall display the availability of stocks of such unadulterated edible oil prominently in his place of business and shall also report the availability of such stocks of edible oils at the close of every fortnight ending on the 15th of the calendar month and the close of the calendar month to the Sub Divisional Officer of the sub division in which his place of business is situated.

Procedure for identification of stocks of unadulterated mustard oil in the possession of dealers at the commencement of the order:

To remove any doubt regarding the safety of mustard oil ordinarily kept by him for sale, any dealer who has in his possession any stock of mustard oil shall ascertain whether any such stock or part thereof is adulterated in the same manner as in sub - clause(1) of clause 3 and if on analysis any sample is found to be adulterated he shall withhold it from sale and send an intimation to the Sub-Divisional Officer of the sub-division in which his place of business is situated.

If on analysis referred to in sub-clause(1), it is found that the sample is not adulterated, the dealer shall get his stock marked in the manner described in the sub-clause(3) and shall display the availability of

stocks of such repacked and marked mustard oil prominently in his place of business and shall also report the availability of such stocks of mustard oil at the close of every fortnight ending on the 15th of the calendar month and the close of the calendar month to the Sub-Divisional Officer of the sub division in which his place of business is situated.

- (3) The marking referred in sub-clause(2) shall -
- (a) in the case of mustard oil in packs, be in the form of a sticker of dimensions 4cm X 4cm consisting of the mark specified in Schedule-II duly affixed on the pack; and
  - (b) in the case of mustard oil in loose, shall consist of a mark of the size 4cm X 4cm as in Schedule-II printed on the pack or tin in which such oil is packed before it is kept for sale.

5. Procedure to be followed by manufacturers/packers dealers selling edible oils including mustard oil after the commencement of the Order to dealers in Delhi.

- (1) Every manufacturer or packer selling or despatching, as the case may be, any stock of edible oil including mustard oil either in a tanker or in packages to any dealer in Delhi shall ensure that -
  - (a) the stock is accompanied by a certificate of the result of the analysis of a sample from the stock from a competent laboratory, in case the stock of edible oil is sold in a tanker; and
  - (b) each package contains the certificate given in Schedule-III printed thereon in a panel of size 8cm X 3cm.
- (2) Every dealer shall display prominently in the places of his business the particulars of stocks of unadulterated edible oils acquired by him after the commencement of this Order and shall also report the position of availability of unadulterated edible oils kept for sale, at the close of every fortnight ending on the 15th of the calendar month and the close of the calendar month to the Sub Divisional Officer of the sub-Division in which his place of business is situated.

6. Form of report to Sub Divisional Officer :  
The report made by any dealer under sub-clause (3) of clause 3, sub-clause (2) of clause 4 and sub-clause (2) of clause 5 shall be in Form A, and shall be made to the Sub Divisional Officer within three days after the close of the fortnight to which it relates.

7. Custody of stocks of edible oils and return of adulterated edible oils.

1) Every dealer shall ensure that the stocks of unadulterated edible oils are segregated from the stocks of other edible oils, samples of which have been sent by him for analysis to a competent laboratory.

2) If on analysis of a representative sample of any stock of edible oils in his possession at the commencement of the Order or received by him after such commencement, a dealer finds any stock of edible oil or part thereof to be adulterated, he shall return the same to the

dealer from whom the said stocks were received and shall intimate the fact of return of the stocks to the Sub Divisional Officer of the sub-division in which his place of business is situated.


8. Compliance with the order of Court or of an authority acting according to law:

Every dealer shall withhold from sale, stocks of edible oil if required to do so by an order of the court or an order of any authority acting according to law.-

9. Exemptions:

- (1) The dealers who do not have in stocks, at any time, 10 Quintles or more of edible oils, including mustard oil, are exempted from the requirements of this Order of submitting fortnightly reports to the Sub Divisional Officers.
- (2) The Lt. Governor may exempt any other class or category of dealers from all or any of the requirements of this Order subject to such conditions as he may stipulate.


